LOCAL AND STATE NEWS OF INTEREST

Condensed Items Gathered from Various Sources for the Busy Reader.

Funeral services for Mrs. Margaret Bishop, aged 59, whose death occurred Saturday night in the Clearfield hospital, were conducted at 2 o'clock Tuesday afternoon in the LaJose Baptist church. Interment was in the LaJose cemetery.

Andrew Lesenski five-year-old son of Mr. and Mrs. Walter Lesenski, of Lilly, suffered the loss of three fingers Tuesday of last week when he had his hand caught in a corn tetter. He was given first-aid treatment and later removed to the Mercy Hospital Johnstown.

Funeral services for Mrs. Luella Mae Mervine, aged 22, whose death occurred at her home, Friday afternoon, were held at 1 o'clock Monday afternoon in the Bel-sano church. Interment was in the Bel-sano cemetery.

Skidding on the ice-coated highway near the estate of Charles M. Schwab early Saturday morning, a car driven by John Bundy of Somerset was overturned and the driver and three occupants were injured slightly. About 50 feet of the iron fence surrounding the steel magnate's estate was torn down by the crash which damaged the automobile.

Dominick Dino, of Yankeetown, near Homer city, is a patient at the Indiana Hospital, suffering from two gunshot wounds of the abdominal region, and Indiana County authorities are searching for his father-in-law, Joseph Pario, of that place, who is charged with the shooting. Neither the father nor the son have penetrated the abdominal cavity and the injured man was reported to be resting fairly well. Dino is alleged to have married Prato's daughter recently against the wishes of the father and the shooting is thought to have been the outcome of the father disliking for his son-in-law.

AUTO DRIVERS GIVEN EXAMS AT EBENSBURG

A total of 24 applicants for automobile drivers' permits were examined by State Highway Patrolmen connected with the Altoona sub-station of the State Highway Patrol Ebensburg last Thursday. Eighteen of this number successfully passed the examination and six failed. Corporal Henry Isban and Patrolmen Lawrence Corson, Edward Williams and Chester Hover conducted the examinations.

Mayor Cauffiel Starts Jail Term

Shortly before 4 o'clock Monday afternoon the outer doors of the Cambria county jail swung shut behind Joseph Cauffiel mayor of Johnstown, who surrendered to the warden of the institution to start serving a sentence of two to three years imposed upon him for official misconduct, following a trial in the court of common pleas last March. Only favorable action by the state pardon board, which will consider his application at its meeting Jan. 15 in Harrisburg, can serve to reduce the time he must spend in prison.

Cauffiel's last hope for a stay of execution of the trial court's sentence, which was sustained by both the state superior and supreme courts, went glimmering Monday morning when, in an opinion written by President Judge John E. Evans and concurred in by Judge John H. McCann, the county court denied a petition for a limited parole until such time as the pardon board could act upon his case.

Cauffiel's repeated allegations of innocence were dismissed in the opinion which pointed out that "if the members of the court of Cambria county who sat and reviewed the defendant's case had believed him innocent, he would not have been sentenced, but no member of this court holds any such opinion. The sentence in this case was determined upon after consultation with, and with the approval of all the members of that court at that time and has been passed upon by a total of 29 men—the jury of 12 the three judges of this county and the seven judges of each of the superior and supreme courts, and there has not been a single judge who, through dissent, said a conviction was not right or not a lawful one sustained by the evidence."

Despite the fact that Joseph Cauffiel, mayor of Johnstown, is a prisoner in the county jail at Ebensburg where he is serving a sentence of from two to three years following his conviction upon charges of official misconduct, the city administration will continue to function.

Acting under the authority vested in him by the provisions of the Clark act, which provides the modus operandi of the commission form of government in cities of the third class in the state, Calvin Overford assumed the duties of acting mayor as son as Cauffiel passed out of the city limits. The Clark act stipulates that in the absence of the mayor, the superintendent of accounts and finance automatically becomes acting mayor until such time as the mayor returns, or a successor is appointed or elected.

COURT DECISION SUSTAINS COUNTY CONTROLLER IN HIS STAND ON PAYMENT OF FEES

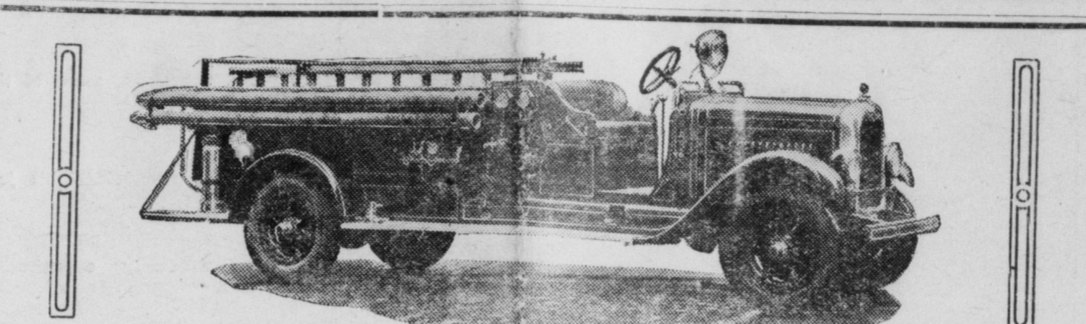
Sustains Stand of Controller

In effect, the court's opinion holds that the controller is correct in refusing to pay the increased fees provided in the 1929 act to those justices of the peace and aldermen who have not been elected re-elected or appointed since the effective date of the act.

PATTON'S NEW FIRE FIGHTING EQUIPMENT



Pictured is the new American-LaFrance Type 99 motor fire apparatus recently purchased for the Patton Fire Department. The apparatus, which arrived in Patton during the week from the company's plant at Elmira, N. Y., insures the local department of one of the most modern and efficient types of fire apparatus made.

It is equipped with a powerful 89 horsepower motor and has four wheel mechanical brakes. The LaFrance rotary gear pump, with which the apparatus is equipped, has a rated pumping capacity of 500 gallons of water per minute. Besides a Rough Rider, soda and acid type of extinguisher, the apparatus is provided with a Foamite extinguisher, fire department type, capable of producing 20 gallons of fire-killing Firefoam. Other equipment includes: Two lengths of suction hose, 10 feet, six inches long and mounted securely on the side of the apparatus; one 20-foot American-LaFrance solid side extension ladder with rapid hoist device and one 12-foot ladder with folding hooks, as well as miscellaneous equipment, including an electrically operated siren, pike, crowbar, and all necessary operating tools. The hose compartment of the apparatus is strongly built of sheet steel and has a carrying capacity of 1,200 feet of two and one-half inch hose.

The apparatus is attractively finished in fire department red and trimmings and equipment are heavily nickel plated.

TREASE AQUARIUM IS BADLY DAMAGED BUILDING WRECKED

An explosion caused by an accumulation of gas of sufficient force to completely demolish the small building housing it did much damage to the aquarium of Robert E. Trease, of Ebensburg, on Saturday afternoon.

Mr. Trease is a breeder of fancy fish of which he had a large and valuable collection, and which he kept in a small building at the rear of his residence, heated by means of gas registers. On Saturday afternoon Mr. Trease, in company with Dr. Ralph M. Wolford, of Johnstown, entered the building and discovered one of the gas burners had become extinguished. When he attempted to relight it the explosion occurred. The building, 10 by 12 feet in size was completely wrecked and the men were nearly buried about the face and hands, but were not otherwise seriously injured. The explosion was felt several blocks away.

Prior to the explosion Mr. Trease had 32 different varieties of fancy fish from all parts of the world and he estimates that approximately 750 fish were killed by the explosion. There were also a number of tanks and bowls destroyed, the loss being estimated at between \$450 and \$500 with no insurance to cover.

HEAVY SENTENCES FOR LIQUOR LAW VIOLATORS

At the weekly session of motion and petition court Monday, Stephen and Anthony Pavlick, both of East Conemaugh, who pleaded guilty to charges of robbery, were sentenced to pay the costs, make restitution and serve not less than three months nor more than five years in the county jail.

Bruce Smith pleaded guilty to fraudulently uttering a written instrument and was let off with payment of costs and a suspended sentence.

Elmer Gray of Spangler pleaded guilty to a liquor charge and was sentenced to pay the costs, a fine of \$100 and serve not less than three months nor more than three years in jail.

John Materowski of Clearfield pleaded guilty to violation of the liquor laws and was sentenced to pay the costs, a fine of \$100 and serve not less than three months nor more than three years in jail.

A. H. Sanker of Cresson pleaded guilty to a charge of larceny and was sentenced to pay the costs and to serve two months in jail.

TRUCK RUNS AMUCK

Sliding backwards down the Main Street in Gallitzin at 4:30 o'clock Sunday afternoon a gasoline tank truck owned by the Gulf Refining Co. crashed into the front of a branch store of the Great Atlantic and Pacific Tea Co. at that place demolishing two plate glass show windows, as well as much of the stock in the store. Two pedestrians, standing on a corner a few feet distant from the scene of the crash, escaped injury by leaping into the street and the wild truck missed plowing into the front of the Citizens Depositing bank by only a narrow margin. No reason could be given for the truck running wild, as the operator, R. S. Beecher, 40, of Altoona, said the brakes had been applied properly before he stopped the cumbersome vehicle. The truck escaped serious damage and was able to proceed under its own power. Damage to the property was estimated at approximately \$200.

MARGARET BLOWDEN REESE

Miss Margaret Blowden Reese, aged 16, daughter of William H. Reese and Rachael Jones Reese of South Ebensburg, died at 1:10 o'clock Saturday afternoon at her home, where she contracted pneumonia Christmas day. She was a junior in the Ebensburg High school and had a perfect attendance at school for the last seven years.

HASTINGS MEN HELD AS ALLEGED TRANSPORTERS OF 90 GALLONS OF LIQUOR

Charged with transportation of 90 gallons of alleged whiskey, Rosario and Joe Castinovo both of Hastings, are being held in the county jail pending a preliminary hearing before Justice of the Peace James T. Young. The men were arrested Saturday morning near Ashville by highway patrol officers from the Hollidaysburg sub-station, who reported finding the liquor packed in six 15-gallon containers in the car driven by the men. Following the arrest the highway patrol officers turned their prisoners over to the state police at Ebensburg and the charges were lodged.

EXPLAIN CHANGES MADE IN BODIES OF MODEL FORD

MANY MOTORISTS MAKE ERROR IN WRITING CHECKS

Fifteen percent of motor car owners who are senti neglecks to the Bureau of Motor Vehicles covering the fee for their 1930 registration plates, are mailing checks made out to the "State Highway Department." The Bureau of Motor Vehicles has not been part of the State Highway Department since June 1, last. It is now a division of the Department of Revenue which collects all moneys due the Commonwealth, and supervises the issuance of all licenses. Car owners who send checks made out to the State Highway Department have made it necessary for that department to endorse checks over to the Department of Revenue.

MRS. CATHERINE KAYLOR

Mrs. Catherine (Nagle) Kaylor, aged 90 years, a native of Cambria County, who had lived in Altoona for the last 74 years, died of a complication of diseases early Thursday morning at her residence on Ninth street. She had been bedfast for the past four months.

Mrs. Kaylor was born of St. Boniface, September 17, 1839, a daughter of George and Sarah (Daugherty) Nagle. She came to Altoona when but 15 years old, securing employment as a nurse girl with a Altoona family. Prior to coming to Altoona she had been employed at the Old Fountain Inn above Duncansville.

On April 11, 1889, she was united in marriage with James Kaylor, who died in 1914 at the age of 94 years. Two children were born to the union, a son and a daughter. The son died shortly after the father while the daughter, Mrs. Rebecca Mathews, also resides in Altoona.

The funeral was held Saturday morning with requiem mass at 9 o'clock at Mt. Carmel Church, interment was in Calvary Cemetery.

Patton Young Lady A Victim of Bandits

While returning to her home near here last Saturday evening after making some industrial insurance collections for her father, Mildred Mellon, 25-year-old school teacher, was held up and robbed by two masked bandits along the Indiana-Glen Campbell highway in Indiana County. The bandits succeeded in getting her wrist watch, a ring, \$33 in cash and two insurance books, after which they fled in the direction of Indiana.

Stepping from behind a parked coupe almost across the highway the two bandits jumped on the running board and armed with a revolver and a knife, commanded Miss Mellon to stop. When they demanded her money she screamed and one of the highwaymen slashed her with a knife across the face, inflicting a painful wound and the other bandit twisted her arm and broke a bone in her wrist. Miss Mellon was picked up by a passing motorist and taken to the office of a physician at Glen Campbell and after receiving medical attention was removed to her home near here.

It is said that the two bandits were apprehended by the Indiana county police authorities on Wednesday and that both of them reside in the vicinity in which the hold-up took place.

WILL SEND NOTICES TO TAX COLLECTORS

Secretary of Agriculture C. G. Jordan and John L. Passmore, in charge of dog enforcement activities, asserted at Harrisburg recently that the State will not tolerate delay among owners in securing 1930 licenses for dogs. "The law requires that every dog must be licensed not later than January 15," they explain. "Dog owners who disregard the law are subject to a fine of \$5 to \$100 or a jail sentence of 30 days."

"The County Treasurer is the only official in a county who can issue dog licenses. Dog owners can secure licenses directly from the County Treasurer's office or make application to a local Justice of the Peace, or magistrate, who will submit the properly executed application with the fee to the County Treasurer. The license will then be mailed."

"The Pennsylvania Department of Agriculture does not want to prosecute anyone, but the law will be vigorously enforced. Negligent dog owners must be prosecuted or innocent people will suffer."

"Rigid enforcement of the law protects the livestock industry and birds, especially young rabbits and wild turkeys from the ravages of dogs. It protects human life from the menace of rabies; it reduces the annoyance and damage caused by dogs roaming over lawns and flowers.

"The public must continue to have this protection from the uncontrolled dog."
