LOOKING AHEAD By LEN De CAUX

What has been happening in 'bloody' Harlan county today, brings to mind another "field of blood."

The Bible relates that when Judas Iscariot repented and took his thirty pieces of silver to the temple, the chief priests would not put them in the treasury because they were the "price of blood."

Instead they bought with them the potter's field, to bury strangers in; "wherefore that field was called the field of blood unto this day."

Bloody Harlan has its Judas today in the person of Governor Chandler. Alongside the miners killed in the fight for unionism, whose memory and whose living fellows he has betrayed, Chandler has dug his own political grave in Harlan's "field of blood."

The slow, deliberate words of John L. Lewis at the textile workers' convention were the soil thrown over the remains of Chandler's political career. He left only a double cross to mark the spot.

A Night of Betrayal The huge audience listened breathlessly while Lewis told the simple, sordid story of Chandler's betrayal of the miners.

Like Judas, "Happy" Chandler broke bread with and swore his loyalty to those he was to betray, on the very evening he was planning a deal with their enemies. Like Judas, he betrayed them with a kiss.

Lewis related how Chandler pledged himself to give a square deal to the miners and to all labor, at a meeting of 35,000 miners in Pikeville, Ky. That night he came to Lewis' hotel room, and when he left at three o'clock in the morning, with tears streaming down his cheeks he swore that he would never forget what the miners were doing for him and would always keep the faith with them.

Chandler must have heard the cock crow in that early morning after he left Lewis' room, just as Judas heard the cock crow on the morning of Christ's betrayal.

For at half-past eight that very morning he left the hotel on his own Judas mission. "It was several months after," Lewis said, "before I found out

that when he left the hotel that morning he drove to a secret rendezvous to meet a committee of Harlan county operators with whom he made a dishonorable deal."

While Lewis was speaking, the newsboys outside edged in to hear what he was saying.

And when the audience left the hall, they were greeted with the newsboys cry: "Read about Doublecross Chandler! Doublecross Chandler sends more troops!"

More troops—that was the only answer that the grinning madman from Kentucky could make to the exposure of his treachery.

The artificial smile must have cracked on his face when he read Lewis' speech.

The man who unsheathed the sword where peace prevailed—who sought to drive the Kentucky miners back to work with bayonets on the eve of the nationwide coal agreement—must have seen in the newspaper headlines the handwriting on the wall.

The now unhappy Chandler must know his political days are numbered. For the political Judas, like the scab, is despised by those who use him as well as by those he betrays, and is scorned by all honest men.

Little Men in Office The United Mine Workers of America, fresh from the greatest triumph in history, has little to fear from the Chandlers and other "dishonorable little men in office," as Lewis called them. The potters field of politics is strewn with their bones.

The miners of Kentucky will know how to deal politically with their Chandler, just as the West Virginia miners will know how to deal with their Rush Holt at the polls.

But each such story of labor betrayal deserves repeating and remembering, for the lessons it teaches of the need for union and political organization, so that the workers may not have to "depend upon the whims and the caprices and the mad impulses," as Lewis put it of the Chandlers and their ilk.

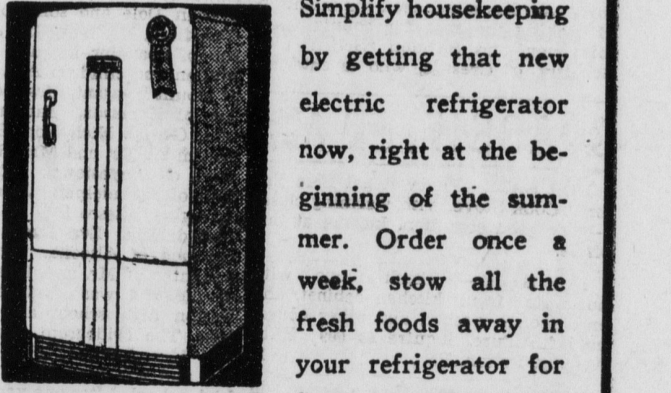
