Blood Poisoning Resulted. Dr. Dovere, a prominent resid nut of Pittston, has had a narrow escape from doubt. Last week he attended a patient who was sick with a mayligamat attack of diptheria. One day he scratched the end of one of his thumbs, but not enough to break the skin. He paid no atten-tion to the scratch and called on his diptheria patient and gave the usual treatment. In some way a diptheritic microbelodged on the scratch. In a few hours the fault began to thoto and beat and then began to pain severely. With the pain came a swelling; and the entire thumb was soon swollen to more than double its original size, and the pain bogan to spread through the entire arm. The doctor found it was blood poisoning of the worst kind, and was at last compelled to remain in the house. 
