Fatal Explosion.

Three men were killed, six more probably fatally injured and nineteen others more or less seriously burned by an explosion at Buck Mountain colliery, Schuylkill county, on Friday. Edward Gallagher, a repairman, with a flaming mining lamp, went into an old abandoned breast to secure a plank. He is alleged to have accidentally touched off the gas.

James Griffiths, aged 40, Mahanoy City, was killed outright, and John McGlynn, aged 17, Buck Mountain, and Charles Jones, aged 50, Buck Mountain, have died from their wounds. Joseph Strokonas, aged 30, Buck Mountain; Henry Obrecht, Mahanoy City; Edward Gallagher, aged 60, Buck Mountain; Daniel Shovellin, aged 55, Buck Mountain, and Andrew Haverilla were seriously burned.

Gallagher died yesterday from the effects of his injuries, and at an early hour this morning David Lenardy, whose injuries were considered not serious, also died.

Michael Butzkis, David Jenkins, Louis Bartell, Charles Smith, Joseph Sudikas, Joseph Silkonas, Paul Yutko, Andrew Pierce and others were painfully burned. Three of the victims, Jones, Shovellin and Gallagher, were at one time residents of this vicinity; Jones having lived many years at Upper Lehigh, Shovellin at Highland and Gallagher at Freeland.

As far as can be learned, the explosion was apparently due to Edward Gallagher going into an abandoned working with a naked lamp and igniting the gas, which had accumulated. Gallagher had been ordered to procure a plank for the purpose of making repairs, and the fire boss, William Moses, says he admonished Gallagher not to enter that abandoned working. Gallagher, on the other hand, says he received no warning whatever.

TO BE BURIED HERE.

Charles Jones, one of the victims of the terrible explosion at Buck Mountain colliery on Friday, will be buried here tomorrow. The remains are expected to arrive at 11.45 a. m., and will be taken to Freeland cemetery for interment. Mr. Jones was a resident of Upper Lehigh for many years and had a large number of friends in this section. The deceased was a brother of Mrs. Thomas Parry, Upper Lehigh.

End of Tragic Romance.

The State Board of Pardons has pardoned Frank Bezek, who six years ago was convicted of killing his sweetheart, Maria Kerzac, at Olyphant, Lackawanna county. He was sentenced to be hanged, but afterward the sentence was commuted to imprisonment for life. Bezek and Maria Kerzac were lovers in Croatia, Austria, according to evidence brought out at his trial. He preceded her to this country and worked in the mines, and when he had accumulated sufficient money he sent for the woman to come to this country.

She soon afterward arrived and went to the home of a relative in Olyphant. But before the wedding day another man appeared on the scene, supplanting Bezek in the affections of the young woman. Bezek came down to Olyphant to claim his bride, and was turned away. He then shot her dead.

At the trial it was attempted to be shown by the defendant that he was down-hearted and attempted to commit suicide. In doing so, it was said, the women pulled the revolver around so that when it was discharged, the bullet pierced her neck, fatally wounding her.

Water Famine Feared.

The drought in the coal region is becoming more serious daily. The Philadelphia and Reading Railway at Mahanoy Plane is now compelled to haul water in oil tanks from Sunbury, a distance of forty-one miles. At Shenandoah the water from the public works is turned on but three hours each day, two hours in the morning and one hour in the evening. For domestic purposes enough of this scant supply is stored to serve for twenty-four hours.

Reading Coal Company collieries depend almost entirely on sulphur water pumped from the mines and purified with the assistance of lime. This is well enough as a temporary expedient, but its continued use means sure destruction to the boilers. The sulphur water eats away the tubes and the boilers are useless within a month.

THEATRICAL.

Augustus Pitou's naval drama, "The Gunner's Mate," is to be presented next Friday evening for the second time in Freeland. This play is from the pen of a man well calculated to picture, in a consistent and true-to-life manner, the incidents and every day happenings among Uncle Sam's blue jackets. Its author is dramatic editor of the Newark, N. J., Sunday Call. The dramatic experience and familiarity with nautical lore cannot fail to produce a play that will appeal most forcibly to the American public. When to these considerations are added the fact that the production is under the management of Augustus Pitou, its claim upon the attention of a patriotic theatre-going public can be made no stronger.

Three of the five scenes of the play present actual reproductions of views of the cruiser New York. The story is full of strong sensational effects, with a grateful intermingling of comedy. The scene showing the fire-room of the New York, and the thrilling climax which transpires in it, is one of the strongest imaginable.

Among the special features of the production are a mandolin quartette, a pair of buck dancers and several high-class singers.

Tickets for the lecture by Spillman Riggs on "Musical Misfits, at the Grand tomorrow evening, are going rapidly and the indications are that the second entertainment of the M. & M. course will be largely attended.

William A. Brady's magnificent production of that beautiful pastoral drama, "Way Down East," which, by the way, is the first production ever repeating its run in the city of Boston, and which is now duplicating its Eastern success at McVicker's theatre in Chicago, will be seen here during the season.

Executive Board Meeting.

Benjamin James, of Jeanesville, has been summoned to Indianapolis to attend a meeting of the national executive board of the United Mine Workers. The meeting will be the last to be held by the board before the national convention in January. Matters of grave importance will be considered and the policy to be adopted at the convention will be outlined.

Foremost among these matters is the condition in the anthracite fields. While the miners were victorious in the great strike which has just been settled, this was simply a preliminary skirmish, and a great deal of work remains to be done, it is announced. The primary consideration is to get the operators in the anthracite districts to meet the representatives of the United Mine Workers in annual scale conference.

Abused the Horse.

Rev. J. W. Bischoff drove from his home in Upper Lehigh Monday morning and placed his horse and carriage in the stable, rear of the Presbyterian church on Front street. He then left for Hazleton, going and returning via the trolley line. Arriving here at 1 o'clock he went for his horse and found the animal in the stable reeking with sweat and showing the effects of having been driven hard. The day was cold and the horse was in great danger of becoming ill.

No trace of the party who took the horse and carriage from the stable has yet been found, but it was probably done by some person familiar with the owner's movements. Should the identity of the guilty one be established, he will be prosecuted.

Assistant District Attorney.

The large majority given in Freeland to Benj. R. Jones, district attorney-elect, has started a movement among the friends of John M. Carr, Esq., with the object of securing for him the appointment by Mr. Jones of assistant district attorney. Mr. Carr is well qualified for the position, and his friends feel that his work for the party in the late and previous campaigns deserves consideration.

Other lawyers whose claims are being pushed for the appointment are Greenville J. Clark, E. F. Cook, John D. Farnham, W. H. McCartney and B. F. Meyers.

Public Meeting Tonight.

A public meeting will be held this evening at the Grand opera house in the interest of the striking employes of the Freeland silk mill. "Mother" Mary Jones, the famous labor organizer, and other speakers will address the meeting. The committee in charge extends a cordial invitation to all citizens of Freeland and vicinity to attend the meeting.
