Milkman Frank H. McGroarty's Wagon Demolished by a Train. Demolished by a Train. Frank H. McGroarty, the well known milk dealer, had a narrow escape from death this morning at the Centre street crossing of the Lehigh Valley Railroad. His wagon was struck by the train ar-riving from Wilkesbarro at 9.30 o'clock, and with the exception of the two front wheels nothing remains of the vehicle but pieces.

He failed to notice the approaching train, or to hear the shouts of the people at the station, until his wagon was on the tracks. It was then too late to escape by the side door of the wägon, but he shouted to the horse. The animal bounded for-ward, but not far enough to clear the rails, and the engine struck the vehicle a short distance back of the centre, lift-ing the wagon and contents in the air and dashing them with terrific force to the station platform. Mr. McGroarty was in the midst of the wreck and escaped with a few cuts on the head and hands. The wagon, milk-cans and bottles were broken be-yond repair, but the horse came out without a scratch. Several people were on the station platform at the time, but were unable to prevent the accident. All who witness-el it were horrified at the sight and be-lieved in the certain death of the driver. 
