### Sunday Fishing Allowed.

The new fish laws of this state, a synopsis of which was published in the Tribune a week ago, are receiving much attention from the newspapers of the state. The Stroudsburg Times has discovered the fact that the act which the governor has just signed is silent regarding Sunday fishing. The editor wrote to W. E. Meehan, secretary of the State Fish Commission, asking for information on this point, and the secretary replied as follows:

"The new laws are very much more liberal than the old ones, I am glad to say. Among other things, you will notice that there is no prohibition against Sunday fishing."

This feature of the law will undoubtedly be welcomed by those who cannot find time to fish on week-days. On the other hand, it will be condemned by all who oppose Sunday pleasure and pastimes.
