AN ORDINANCE AUTHORIZING THE CREATION AND ESTABLISHMENT OF A TOWNSHIP PLANNING COMMISSION FOR THE TOWNSHIP OF KINGSTON, LUZERNE COUNTY, PA.; AUTHORIZING THE APPOINTMENT OF THE MEMBERS THEREOF; DEFINING THEIR DUTIES; CONFERRING AND IMPOSING ON SUCH COMMISSION THE POWERS AND DUTIES OF A TOWNSHIP ZONING COMMISSION; AND AUTHORIZING THE APPROPRIATION OF TOWNSHIP FUNDS FOR THE NECESSARY WORK OF SUCH COMMISSION.

SECTION 1. There is hereby created and established for the Township of Kingston, Luzerne County, Pennsylvania, pursuant to the authority conferred by the Act of Assembly of the Commonwealth of Pennsylvania, approved May 1, 1933, P. L. 103, Article XX-A, Section 2051, as amended, a Township Planning Commission, consisting of five (5) members, who shall be appointed by the Supervisors of said Township for terms of five (5) years, in the manner therein provided.

SECTION 2. The members of said commission shall be: Fred C. Dingle, who shall serve for a period of one (1) year; John M. Porter, who shall serve for a period of two (2) years; Samuel Z. Moskowitz, who shall serve for a period of three (3) years; Lester W. Hauck, who shall serve for a period of four (4) years; and W. Richard Mathers, who shall serve for a period of five (5) years. Annually thereafter, a member of said Commission shall be appointed by the Board of Supervisors for a period of five (5) years.

SECTION 3. The said Planning Commission, and the members thereof acting as such Commission, shall have all the powers and privileges, and shall perform the duties and responsibilities conferred upon such a Commission by the applicable Acts of Assembly of the Commonwealth of Pennsylvania. In addition to the duties and responsibilities imposed upon such Commission by the said Act of Assembly, there is hereby conferred and imposed upon said Commission all of the powers and duties conferred upon Township Zoning Commissions by the Act of Assembly of the Commonwealth of Pennsylvania approved May 1, 1933, P. L. 103, Article XX, Section 2006, as amended.

SECTION 4. The Board of Supervisors of the Township of Kingston, Luzerne County, Pennsylvania, are hereby authorized, from time to time, to make such appropriations from the General Fund of said Township as, in their judgment may be necessary or desirable to carry on the work of said Commission.

SECTION 5. The provisions of this ordinance are severable, and if any of its provisions shall be held illegal, invalid or unconstitutional, the decision of the Court so holding shall not affect or impair the remaining provisions thereof. It is hereby declared to be the legislative intent that this ordinance would have been adopted if such illegal, invalid or unconstitutional provisions had not been included herein.

SECTION 6. This ordinance shall become effective December 24, 1960. ENACTED AND ORDAINED at a regular meeting of the Board of Supervisors of Kingston Township held on Wednesday, December 14, 1960.
