The rules, as set forth in the election code, are specific. To qualify, a person in military service, he said, need only follow these rules: "Any qualified elector in actual military service may apply at any time before election for an official military ballot on form USWBC Form No. 1, or any other form supplied by the Federal Government. Application for military ballot may also be made by requesting in writing to the Secretary of the Commonvealth of Pennsylvania or the Coun-Board of Election of the County in which his voting residence is located.


