

### Dallas Ambulance Presents Rules

#### Section I—Persons Entitled To Service

This Association's equipment shall be used only for service to residents of Dallas Township and Dallas Borough and to visitors of such residents and to persons injured while traveling through said municipalities; Provided, however, that the ambulance shall respond to calls for service requested by any other association with which this Association shall enter into an agreement for reciprocal ambulance service; and Provided further that the ambulance may respond to calls for service requested on behalf of residents of immediately adjacent municipalities not covered by such reciprocal agreements, in which case an appropriate fee shall be charged as established from time to time by the Board of Directors. All service to residents of Dallas Borough or Dallas Township shall be free of charge. The Board of Directors may, by resolution, place in effect appropriate fees for service to any other persons.

#### Section II—Radius Limitation

This Association's equipment shall not be used for calls requiring delivery of the patient to a point beyond a radius of twenty-five miles from the registered office of the corporation, except in the following cases:

(1) At call of proper governmental authority in cases of general catastrophe in the local area, state or nation.

(2) The radius limitation shall be extended to, but not in excess of, two hundred miles, when, and only when, all of the following conditions exist:

(a) A request for such service is made by a Doctor of Medicine, and

(b) the patient to be served is a resident of Dallas Borough or Dallas Township, and

(c) arrangements are made in advance for coverage of the Borough and the Township by some other ambulance association with which this Association has a reciprocal agreement, and

(d) a Registered Nurse or Doctor of Medicine is present in the ambulance during the entire period from the time the patient is picked up until the patient is delivered to his or her destination.

#### Section III—Call of Physician In Charge

The Association's equipment shall be used only upon the call of physician in charge, except in cases of sudden injury, and then only in cases where a physician cannot be contacted and brought to the scene within a reasonable time; Provided, however, that in cases of general catastrophe in the local area, state or nation, upon call of proper governmental authority (including state and local police, civil defense officials, etc.) the equipment may be used at any time without any restriction as to radius of operation or as to persons served.

#### Section IV—Delivery to and From Hospital

The Association's equipment shall not be used for any purpose other than transportation of patients to and from hospitals, except in cases of general catastrophe in the local area, state or nation.

#### Legal Notice —

##### DALLAS TOWNSHIP EARNED INCOME TAX

Notice is hereby given that the Supervisors of Dallas Township intend to enact an ordinance imposing a tax of one per cent (1%) on earned income of residents of Dallas Township and on income earned in Dallas Township by non-residents of Dallas Township. Such ordinance will be enacted under the authority of the Local Tax Enabling Act (31 December 1965, No. 511). It is intended that such ordinance become effective on the 1st of January 1967.

In the judgment of the officials of Dallas Township, the imposition of this tax is necessitated by the need for funds for the general purposes of Dallas Township, including (1) the expenses of the Dallas Township Planning Commission, (2) extensive repairs to or replacement of the township garage, and (3) the maintenance of roads in the township. The amount of revenue estimated to be derived from this tax is \$30,000, per year.

The Supervisors of Dallas Township will consider enacting such ordinance at a special meeting to be held at the Dallas Senior High School (in the Library) on Monday, November 21, 1966 at 7:00 p.m., E.S.T. All persons interested may attend such meeting and be heard.
