


ing another child. Mrs. Kile's mother also lives in the house. A man who is advising Mr. Kile on how to repair his home has told him that a cinder block wall will not do, as it will not hold up long against the water which washes against it. Mr. Kile will probably rebuild the stone wall.

Tom Bagley, manager of the DAMA sewer treatment plant, has told the Post that DAMA will consider the Kiles' problem at their March 21 meeting. When Mr. Bagley reported this before the wall fell onto the drain pipes, DAMA was mainly planning to consider whether they would allow the man to drain his water, into the sewer system "on a temporary basis...until perhaps PennDOT goes in there and does something that will end (the) prob-

Mr. Bagley gave the opinion that Mr. Kile's only other course would be to seek legal action, to prove that Marona Construction was responsible for the incoming water. Mr. Bagley pointed out that the flooding of 1972 might instead prove to be the cause.




