


Twp. sued

A suit has been filed against Dallas Township Board of Supervisors and Elmer Reese, trading as Rick Reese Excavating, for more than \$10,000 for damage done to the property of Dorothy

Mrs. Henney claims that 22 trees were cut on her property in Kunkle which borders on the proposed little league baseball field. Last year the township supervisors contracted with Reese to cut down a group of trees adjacent to the field in preparation for the recreational program which they had initiated.

The trees were located between two stone walls. The contractor cut a stand of trees which they thought were on township property but which are alleged to have been on Mrs. Henney's land.

Mrs. Henney's suit contends that the trees were worth \$2,000 and the damage done amounted to \$3,000 plus there was 'severe emotional anguish suffered from the loss.

## Dallas plans new tax

Dallas Borough Council has publicly served notice of its intention to pass an ordinance to levy a \$10 occupational privilege tax on persons employed within the borough. (See full text of notice on page

Council will share the tax 50-50 with Dallas School District rather than pass an ordinance to attach onehalf of the school district's right-to-work tax.

The \$10 occupational privilege tax was first passed by the Dallas School District earlier this year as a means of raising additional income needed for the 1978-79 district budget.

If Dallas Borough Council passes the occupational privilege tax ordinance and the school board does not reenact the tax next June, the borough could collect the full \$10.

According to the proposed 1979 budget of Dallas Borough the nine mills will remain the same with anticipated expenses ficials emphasized that persons employed in the borough pay the tax only once annually and to only one governing body, either the school district or the municipality.

will enable Dallas Borough to attach \$5 of the school district's levy

One borough official said that he does not like the proposed ordinance because he does not believe the additional revenue is needed.

Ralph Garris, council secretary, said that council members believe that some of the occupational privilege tax should be received by the borough because of the expense incurred due to the large number of business places in the borough.

Garris said that the increasing number of businesses require that council provide extra police protection and road clearing services. Borough road workers are responsible for all the
