

ORDINANCE DATED NOVEMBER 9TH. 1966 PROHIBITING THE DISCHARGE OF ANY KIND OR TYPE OF GUN, RIFLE, SHOTGUN, REVOLVER, PISTOL OR OTHER FIREARM, FLOBERT RIFLE, AIR GUN, SPRING GUN, OR ANY OTHER IMPLEMENT WHICH PROPELS, WITH FORCE, A METAL OR OTHER PELLET OR DART OF ANY KIND, EXCEPT IN THE NECESSARY DEFENSE OF PERSON OR PROPERTY, WITHIN THE TOWNSHIP OF KINGSTON, AND PRESCRIBING THEREOF.

PENALTIES FOR THE VIOLATION BE IT ORDAINED BY THE SUPER-VISORS OF KINGSTON TOWNSHIP AND IT IS HEREBY ORDAINED BY

AUTHORITY OF THE SAME, AS FOLLOWS: SECTION 1. No person shall, except as may be hereinafter provided, discharge any gun, rifle, shotgun, revolver, pistol or other firearm, flobert rifle, air gun, spring gun, bow, or any other implement which propels, with force, a metal or other pellet or dart of any kind, or arrow of any kind, except in the necessary defense of person or property, within the Township of Kingston; provided, however, that the provisions of this ordinance shall not be applicable to those areas or sections of the township which are now, or shall be in the future, zoned as "Agricultural"

SECTION 2. Any person who shall violate any of the provisions of this ordinance, shall, upon conviction thereof before any District Magistrate in a summary proceeding, be sentenced to pay a fine of not more than One Hundred (\*100.00) Dollars, and costs of prosecution SECTION 3. All Ordinances or par

ts of Ordinances inconsistent herewith are hereby repealed. SECTION 4. The provisions of this Ordinance are severable, and if any of the provisions thereof shall be held illegal, invalid, or unconstitutional, the decision of the Court so holding shall not affect or impair any of the remaini provisions thereof, it being hereby declared to be the legislative inte that this Ordinance would have bee adopted of such illegal, invalid or un constitutional provision had not been included therein. SECTION 5. This Ordinance shall
