Cardboard tubes covered with gold or silver foil can be used for organ pipes or chimes. Aluminum foil tins can be used to cut out stars and attach the stars to cardboard.

Lots of greens and boxes wrapped with Christmas paper add to the beauty of a display. A spotlight or colored bulbs can be placed to highlight a display.

A committee will coordinate details, select judges and arrange to have photos taken of the winning entries.

Back Mountain schools, churches and business will be included in a special category. Selections of the judges will be final.
