c. Return to the states and local school districts responsobility for public educational programs and the resources that accompany them.

The Commission will meet at least three times during 1981. The meetings will be held in the Harrisburg area. PSBA president Eugene Garvey will serve as chairperson

of the Commission. Since 1975, Dr. Price has served as the Director of State and Federal Programs for the Luzerne Intermediate Unit 18. In that capacity, he has procured more than 3 million dollars in state and federal programs for the Luzerne Intermediate

Unit. A graduate of Lake-Lehman High School, Price received his BS degree in Secondary Education from Bloomsburg State College, his MA in State American History at the University of Scranton, and his Ph.D. in History from Kent State University, Ohio.

A request for a side and his application down, Baur can get a permit to build the two store unit by readjusting his side yard requirements. Baur told the board that if they should veto his application, he intended to apply for a permit. The stores would be

classified as a shopping center as soon as he rented them and would come under shopping center regulations.
