Republican dominated Council at Harveys Lake has voted to give up the idea of a tax-anticipation loan and the \$25 garbage sticker fee. Council met in a special session last week with Margaret Purcell presiding due to the absence of president Frank Coulton.

Also discussed were amendments to the 1983 budget which included elimination of a number of expenses. Proposed budget cuts involve the purchase of a new cruiser, \$10,000; administration expenses, \$300; engineer's salary, \$300; engineer's expenses, \$1,000; codification of borough records, \$2,300; construction and rebuilding for road department, \$11,000 construction supplies and equipment, \$4,000 and \$1,500 for supplies for garbage sticker program.

Dallas Township supervisors plan to invite Meadows Senior Citizen complex planners to a meeting, March 15 at 7 p.m. Purpose of the meeting is to correct a misunderstanding on the use of the fire safety pond constructed at the Meadows. Ecumenical Enterprises Inc., which is constructing the complex has reportedly offered the Township a 25-year lease on the pond for use in fire emergency. Township fathers are looking for a more lasting agreement with EEI, as they believe their financial investment in the project to be too great to span only 25 years. A hearing has been set for Feb. 24, at 6 p.m. before District Justice Leonard Harvey on charges of harassment leveled against Jackson Township patrolman Bert Balliet. Charges were brought by Township resident Robert Hagenbach following an incident which took place after the January supervisors meeting.

District Justice Leonard Harvey will soon hear his first drunk driving case since the Jan. 14 mandated sentencing law took effect. Harvey will hear charges of underage drinking, drunk driving and disorderly conduct brought against 20-year-old Alan Peterson, 90 Main St.,

The charges were filed after Peterson's auto reportedly struck a telephone pole on Lake Street at 1:22 a.m. on Sunday, Jan. 30. Dallas police officer Severn Newberry filed the affidavit with Harvey. He said Peterson was glassy-eyed and staggering. Peterson said the car's steering mechanism failed.

Edsel Allen Salsman, RD 2, Laceyville has waived his right to a preliminary hearing on charges of theft by unlawful taking and theft of services, before District Justice Earl Gregory, Shavertown.

Charges were brought by Dallas Township Police Chief Carl Miers stemming from a Jan. 2 incident at Martin's Mobile Service Station at Kunkle. Salsman was brought to Gregory's from the Wyoming County prison where he is incarcerated in lieu of \$40,000 bail on other charges. Salsman's case will now go to Luzerne County Court.

Back Mountain Legislator appointed

"Proponents of a private system have yet to prove that new taxes would not be necessary to recover the revenues which would be lost if the state got out of the liquor business," he said.

Coslett was also ap-

pointed to the Professional Licensure and Occupational Affairs and Republican Policy committees. As a member of the Republican Policy Committee, Coslett will

help develop party legislative initiatives for the coming session.

Professional Licensure Committee oversees the operations of the Bureau of Professional and Occupational Affairs which regulates many professions which provide services to the public.

"Since the state regulates 22 professions and occupations ranging from architects to veterinarians, everyone in the Commonwealth has some stake in the decisions made by this committee." he said.
