Meadows receives PR award

At a recent ceremony conducted in Hershey, The Meadows Nursing Center in Dallas was presented with a third place public relations award in competition sponsored by the Pennsylvania Association of Non-Profit Homes for the Aging (PANPHA).

The competition, the first such conducted by the organization, was done on a state-wide basis and encompassed several hundred non-profit homes for the aged.

The entry submitted by The Meadows, which only opened in September of 1983, focused on the Nursing Center's program to gain recognition in the community for its services and quality of care. The entry stressed the previous nursing care experience of its newly established staff, the environment and setting of the physical plant, and the philosophy of nursing care to be used at the Center.

The Meadows Nursing Center is the first such effort in the extended nursing care field by Ecumenical Enterprises Inc. - a local non-profit corporation sponsored by the First Presbyterian Church of W-B, the Roman Catholic Diocese of Scranton, the Jewish Federation of Greater W-B, and the Metropolitan Lutheran Council of Wyoming Valley. In its public relations entry, the Nursing Center used

the approach that everyone and everyting was a

possible source of public relations. Some of the means used to promote the Facility were: open house tours, orientation sessions for area hospital personnel and civic organizations; personal contacts through telephone or letter with individuals and organizations; prepared news releases on general informational topics; personal interest stories of personality pro-files; and contacts established through EEI's Board of Directors or sponsoring groups.

Of necessity, the public relations effort involved many people. The program was coordinated by EEI's Executive Director Ray Condo and his Administrative Assistant Richard Rusnok. Others included in the program were Nursing Center Administrator Thomas Sweeney, the various department directors and EEI's Board of Directors.

In accepting the award at PANPHA's meeting, Administrator Sweeney recognized the tremendous effort put forth by the Board and staff alike in making the program successful and also the wonderful cooperation of the local media. Finally, Sweeney noted that it was a great honor for the Center to receive such an award considering that it had not yet been in operation for a full year. He further stated it was his hope that this award would act as a springboard to an even better program in time to come.

Incubator Advisory Board formed


