'CP' the robot visits Gate of Heaven

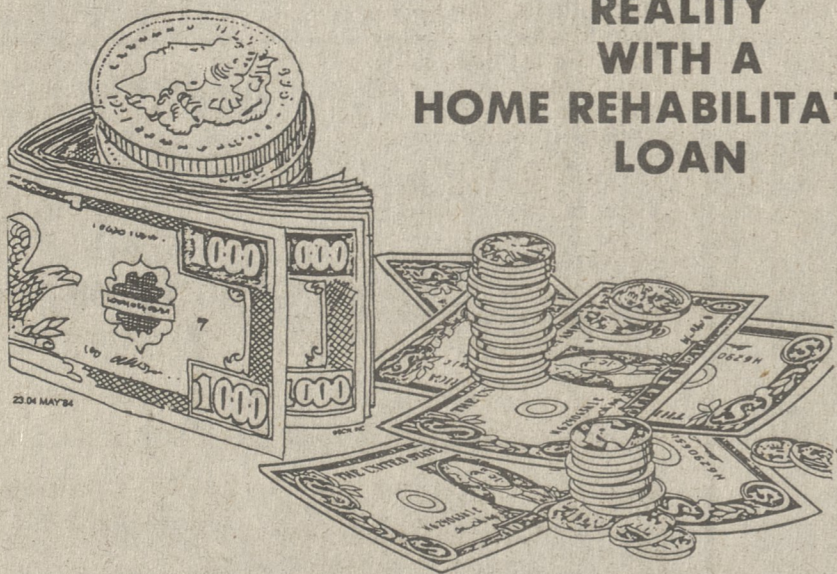
