
Canfield is a U.S. Army Signal Corp veteran of the Korean Conflict. He is a past president of the Dallas Lions Club and a member of the

#### Church women plan projects The Christian Mothers of St.



Due to the Holy Week Services, the next meeting will be held on Tuesday, April 9, preceeded by






