Martha H. Reese

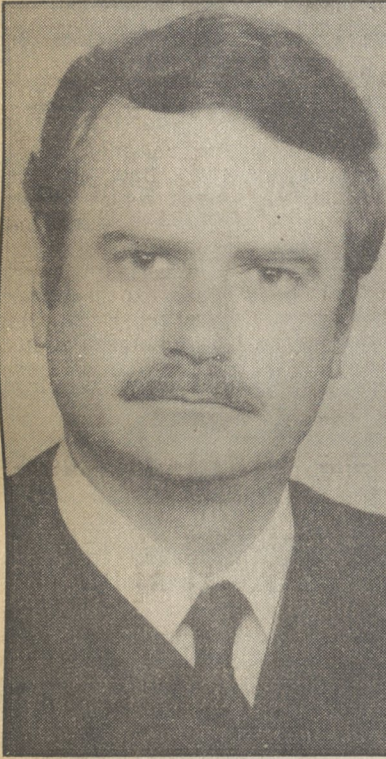

Dominic Caprari

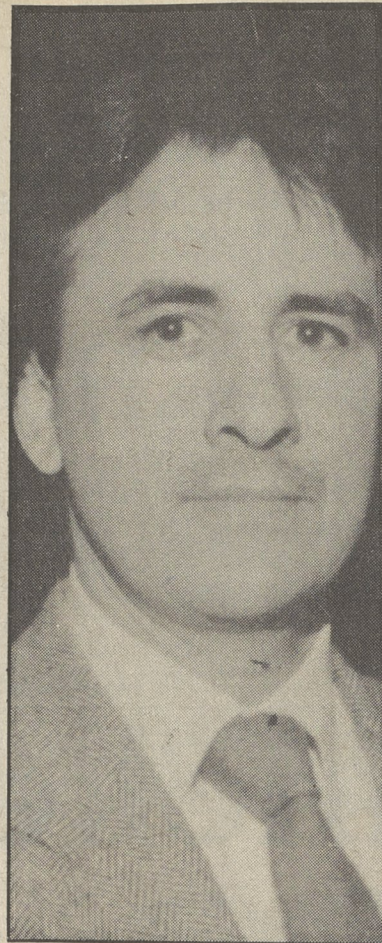

April 22 last day to register

State Rep. George C. Hasay reminded 117th District residents that Monday, April 22, is the last day to register to vote in the municipal primary election.

On May 21, voters will select candidates to run on party slates in the November election.

Rep. Hasay said that to be eligible to vote, a person must be:
-a citizen of the United States for at least a month;
-a resident of the election district for at least 30 days before the primary;
-more than 18 years of age on, before or the day after the primary election.

Citizens who have moved recently or who have not voted in the past two years should check with the courthouse in Wilkes-Barre (Luzerne County) and Bloomsburg (Columbia County) to be sure that their registration is current.

Individuals who need postcard registration forms may obtain them at Hasay's district office at 2261 Sans Souci Parkway. The telephone numbers are 542-7345 and 735-2794.
