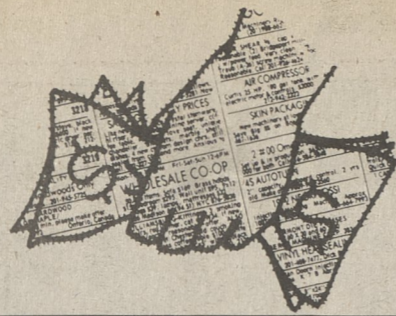

ORDINANCE NO. 1985-6 PROHIBITION OF PARKING ON PORTION OF NORTH MAIN STREET
The Kingston Township Board of Supervisors does hereby enact and ordain, pursuant to "THE SECOND CLASS TOWNSHIP CODE" as prepared in accordance with the HOME RULE CHARTER AND OPTIONAL PLANS LAW, Act 62 of 1972, of the Commonwealth of Pennsylvania, effective January 1, 1976 that:
SECTION I: The parking of vehicles on that portion of North Main Street, Kingston Township, Luzerne County, as depicted on the map attached hereto and made part hereof and delineated in red is prohibited.
SECTION II: Any person violating this ordinance, and the owner of any vehicle parked in violation of this ordinance, shall be subject to a fine and penalty not less than FIVE DOLLARS (\$5.00) and not exceeding FIFTY DOLLARS (\$50.00) in any instance for the violation, which fine and penalty may be collected by suit or summary proceeding brought in the name of the Township of Kingston before any magistrate.
SECTION III: The Manager of the Township of Kingston shall cause signs to be erected at the proper places along that portion of North Main Street where parking of vehicles is prohibited to comply with the applicable provisions of the Pennsylvania Vehicle Code.
SECTION IV: This ordinance shall take

ORDINANCE NO. 1985-8 THE SECOND CLASS TOWNSHIP CODE FOR THE DESTRUCTION OR TRANSFER OF MUNICIPAL RECORDS IN CONFORMANCE WITH THE MUNICIPAL RECORDS ACT, 53 P.S. 1311
The Kingston Township Board of Supervisors does hereby enact and ordain, pursuant to "THE SECOND CLASS TOWNSHIP CODE" as prepared in accordance with the HOME RULE Charter and Optional Plans Law, Act 62 of 1972, of the Commonwealth of Pennsylvania, effective January 1, 1976, that:
SECTION I: That by enactment of the budget for fiscal year 1986, a tax be and the same is hereby levied on all real property within the Township of Kingston subject to taxation for fiscal year 1986, as follows: Tax rate for general purposes in the sum of five (5.0) mills on each dollar assessed valuation, or the sum of fifty cents (\$.50) on each one hundred dollars (\$100.00) of

Historical and Museum Commission, Division of Archives and Manuscripts setting forth the proper procedures for the destruction or transfer of certain municipal records.
SECTION III: In accordance with the requirements of this act, the Board of Supervisors adopts the suggested Retention and Disposition Schedule as outlined for the Local Government Records Committee dated May 17, 1982, and same as which may be amended from time to time.
