AN ORDINANCE DECLARING THE COMMERCIAL EXPLOITATION OF OBSCENE MOTION PICTURE FILMS. PUBLICATIONS, DEVICES, ARTICLES OR INSTRUMENTS, AND THE USE OF MASSAGE PARLORS AND MODEL STUDIOS FOR THE PURPOSES OF LEWDNESS, ASSIGNATION OR PROSTITUTION TO BE CONTRARY TO PUBLIC HEALTH, SAFETY AND GENERAL WELFARE REGULATING CERTAIN CONDUCT OF AND BY PERSONS, PARTNERSHIPS AND CORPORATIONS IN THE BOROUGH, THEREBY PREVENTING VICE AND IMMORALITY, PROMOTING PUBLIC PEACE, SAFETY AND MORALS: PROTECTING PRIVATE AND PUBLIC PROPERTY, PROTECTING THE SOCIAL INTEREST IN ORDER AND MORALITY: PROHIBITING PERSONS FROM SELLING, LENDING, DISTRIBUTING, EVALUATION, DEVICES OR ARTICLES AND INSTRUMENTS, OR ASSISTING IN THE SALE LENDING, DISTRIBUTING OF ANY SUCH MOTION PICTURE FILM, PUBLICATION, DEVICES OR ARTICLES AND INSTRUMENTS, OR ASSISTING IN THE SALE LENDING, DISTRIBUTING OR EXHIBITING ANY OBSCENE MOTION PICTURE FILM, PUBLICATION, DEVICES OR ARTICLES AND INSTRUMENTS, OR ASSISTING IN THE SALE LENDING, DISTRIBUTING OR EXHIBITING ANY OBSCENE MOTION PICTURE FILM, PUBLICATION, DEVICES OR ARTICLES AND INSTRUMENTS, OR ASSISTING IN THE SALE LENDING, DISTRIBUTING OR EXHIBITING ANY EXPLORMENT OF OBSCENE OR PORNOGRAPHIC MATERIAL: PROHIBITING AMPLICATION, PROHIBITING ADVERTISEMENT OF OBSCENE OR PORNOGRAPHIC MATERIAL: PROHIBITING MASSAGE PARLORS OR MODEL STUDIOS USED FOR THE PURPOSE OF LEWDNESS, ASSIGNATION OR PROSTITUTION, AND DESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

SECTION 1. LEGISLATIVE FINDING AND PURPOSE.

The Board of Supervisors of the Borough of Dallas finds that the crass commercial exploitation of explicit sexual conduct through the public exhibition of obscene films and the sale of obscene publications and devices, and the use of so-called massage parlors and model studios for the purpose of lewdness, assignation or prostitution, constitutes a debasement and distortion of a sensitive key relationship of human existence, central to family life, community welfare and the development of human personality; is indecent and offensive to the sense

Any person who, with knowledge of the character and content, either sells, gives away, lends, distributes, exhibits, shows, transmutes, or offers either to sell, give away, lend, distribute, exhibit, show or transmute to another, any obscene motion picture film or any obscene literature, book, magazine, pamphlet, newspaper, story book, paper, comic book, writing, drawing, photograph, figure, image, or any written or printed matter of an obscene nature or any device, article or instrument of an obscene nature, shall be guilty of a summary offense and upon conviction thereof, shall be sentenced to pay a fine not exceeding Three Hundred (\$300.00) Dollars, or undergo imprisonment for a period not exceeding 90 days, or both.

Any person who designs, copies, draws, photographs, prints, utters, publishes or in any matter manufactures or prepares any obscene motion picture film, or any obscene book, picture, film, drawing, magazine, pahmphlet, newspaper, story book, paper, comic book, writing, figure, image matter, device, article or instrument of an obscene nature, shall be guilty of a summary offense and upon conviction thereof shall be sentenced to pay a fine not exceeding Three Hundred (\$300.00) Dollars, or undergo imprisonment for a period not exceeding 90 days, or both.

Any person who, with benefit of the principle o

Any person who, with knowledge of the character and content, produces, presents of directs at obscene performance or participates in the portion thereof which is obscene shall be guilty o summary offense, and upon conviction thereof, shall be sentenced to pay a fine not exceeding Thrubunded (\$300.00) Dollars, or undergo imprisonment for a period not exceeding 90 days, or both.

SECTION 5.

Any person who knowingly participates in, supports or in any way aids or assists any person in selling, lending, distributing, giving away, or showing any obscene motion picture film, or any obscene literature, book, magazine, pamphlet, newspaper, story book, paper, comic book, writing, drawing, photograph, figure or image, or any written or printed matter of obscene nature, shall be guilty of a summary offense and upon conviction thereof, shall be sentenced to pay a fine not exceeding Three Hundred (\$300.00) dollrs, or undergo imprisonment for a period not exceeding 90 days, or both.

SECTION 6. None.

Whoever knowingly writes, prints, publishes or utters, or caused to be printed, published or uttered, any advertisement or notice of any kind giving information directly or indirectly, stating or purporting to state where, how or whom or by what means, any obscene motion picture film, picture, book, writing, paper, comic book, figure, image, matter, article or thing of an obscene nature can be seen, purchased, obtained or had, shall be guilty of a summary offense, and upon conviction thereof, shall be sentenced to pay a fine not exceeding Three Hundred (\$300.00) Dollars, or undergo imprisonment for a period not exceeding 90 days, or both.

SECTION 8.

No person within the Porrough of Dallas, shall willfully or knowingly engage in the business of

Section 8.

No person within the Borough of Dallas, shall willfully or knowingly engage in the business of selling, lending, giving away, showing, advertising for sale or distributing to any person under the age of seventeen (17) yeaps, or have in his possession with intent to engage in the said business or to otherwise offer for sale or commercial distribution to any individual under the age of seventeen (17) years, any obscene motion picture film or any still picture or photograph, or any book, pocket book, pamphlet or magazine, the cover or content of which exploits, is devoted to, or is principally made up of descriptions or depictions of illicit sex or sexual immorality, or which is obscene, or which consists of pictures of nude or partially denuded figures posed or presented in a manner to provoke lust or perversion for commercial gain, or any device, article or instrument of an obscene nature.

No person within the Borough of Dallas shall display at newsstands or any other business establishment frequented by minors under the age of seventeen (17) years or where said minors are or may be invited as a part of the general public, any obscene motion picture film or any still picture or photograph or any book, pocket book, pamphlet or magazine, the cover or content of which exploits, is devoted to, or is principally made up of descriptions or depictions of illicit sex or sexual immorality, or which is obscene, or which consists of pictures of nude or partially denuded figures posed or presented in a manner to provoke or arouse lust or passion or to exploit sex, lust or perversion for commercial gain, or any device, article or instrument of an obscene nature.

SECTION 10. DEFINITIONS.

A "Obscene" as used in this Ordinance (Resolution) means that which is determined as

A. "Obscene", as used in this Ordinance (Resolution) means that which is determined as boscene, applying the following guidelines.

1. Whether the average person applying contemporary community standards would find that the subject matter taken as a whole appeals to the prurient interest;

Whether the subject matter depicts or describes in a patently offensive way sexual conduct of a type herinafter described; and
 Whether the subject matter taken as a whole lacks serious literary, artistic, political or scientific

"3. Whether the subject matter taken as a whole lacks serious literary, artistic, political or scientific value.

B. "Patently offensive", means so offensive on its face as to affront current standards of decency, and shall be deemed to include any of the following described forms of sexual conduct, if depicted or described in a patently offensive way:

1. An act of sexual intercourse, normal or perverted, actual or simulated, real or animated, including genital-genital, anal-genital or oral-genital intercourse, whether between human beings or between a human being and an animal.

2. Sadomasochistic abuse meaning flagellation or torture by or upon a person who is nude or clad in undergarments or in a revealing costume, or the condition of being fettered, bound or otherwise physically restrained on the part of the one so clothed.

3. Masturbation, excretory functions, and lewd exhibition of the genitals, including any explicit close up representation of a human genital organ or spread-eagle exposure of female genital organs.

4. Physical contact or simulated physical contact with the clothed or pubic area or buttocks of a human male or female, or the breasts of the female, whether alone or between members of the same or opposite sex, or between humans and animals in an act of apparent sexual stimulation or gratification.

same or opposite sex, or between numans and animals in an act of apparent sexual stimulation.

5. A device designed and marketed as useful primarily for stimulation of the human genital organs.

6. Male or female genitals in a state of sexual stimulation or arousal, or covered male genitals in a descemibly turgid state.

7. Fellatio, cunnilingus, anal sodomy, seminal ejaculation, or any other exretory function.

C. "Community standards", means the standards of the community from which the jury is drawn or would be drawn if it were the trier of the fact.

D. "Illicit sex; or "Sexual immorality", shall mean:

1. Human genitals in a state of sexual stimulation or arousal;

2. Acts of human masturbation, sexual intercourse, or sodomy;

3. Fondling or other erotic touching of human genitals, pubic region, buttocks, or female breast.

E. "Nude or partially denuded figures", shall mean:

1. Less than completely and opaquety covered: (a) human genitals; (b) pubic regions; (c) buttock, and (d) female breast below a point if immediately above the top of the aerola; or

2. Human male genitals in a discernibly turgid state, even if completely and opaquety covered.

F. "Person: shall mean a natural person, partnership or comporation. Whenever used in a clause describing or imposing a fine or term of imprisonment, or both, the term "Person" as applied to appring the partnership shall mean the partners or members thereof, and as applied to corporation, shall mean the officers thereof.

G. "Knowingly" shall mean having knowledge of the character and content of the material wolved or failure on notice to exercise reasonable inspection which would disclose the content and

character of the same.

SECTION 11.

No person shall own, operate or maintain any massage parlor or model studio, which, as a regular course of business, is used for the purpose of lewdness, assignation or prostitution, and every such massage parlor or model studio in or upon which acts of lewdness, assignation or prostitution are held or occur, is declared to be a public nuisance. Any such person violating this Section shall be guilty of a summary offense, and upon conviction thereof, shall be sentenced to pay a fine not exceeding Three Hundred (\$300.00) Dollars, or undergo imprisonment for a period not exceeding 90 days, or both.

1. "Massage: as used in this section, shall mean any method of treating the superificial soft parts of the human body for remedial, hygienic or other purposes, consisting of rubbing, stroking, kneading, or any similar treatment, accomplished by hand, or by the use of any instrument.

2. "Massage Parlor", shall mean any building or structure or portion thereof, located within the Borough of Dallas which is open to members of the general public, with or without the payment of a fee, at which massage services are offered.

3. "Model Studio" means:

(1) Any premises on which there is conducted the business of furnishing figure models who pose in the nude for the purpose of being observed or viewed by any person or of being sketched, painted, drawn, sculptured, photgraphed or otherwise similarly depicted for persons who pay a fee, or other consideration or compensation or a gratulity, for the right or opportunity so to depict the figure model, or for admission to, or for permission to remain upon, or as a condition for remaining upon the premises; or

(2) Any premises where there is conducted the business of furnishing or providing or procuring, for a fee or other consideration or compensation or gratuity, figure models who pose in the nude to be observed or viewed by any person or to be sketched, painted, drawn sculptured, photographed or otherwise similarly depicted.

(3) Exception. The works "Model studio: do not include:
(a) Any studio which is operated by any college or junior college, public school, or any governmental agency wherein the person, firm, association, partnership, or corporation operating it has met the requirements of the State of Pennsylvania for the issuance or conferring of and is in fact authorized thereunder to issue and confer, a diploma or honorary diploma; or
(b) Any premises where there is conducted the business of furnishing, providing or procuring figure models solely for any studio described in subsection (a) of this subsection.

(c) Any studio operated by a tax exempt, non-profit corporation devoted to the development of an and its appreciation.

(c) Any studio operated by a tax exempt, non-profit corporation devoted to the development of art and its appreciation.

SECTION 12.

The provisions of this Ordinance shall be severable, if any Court shall determine that any word, clause, phrase, sentence, paragraph or subsection of this Ordinance is unconstitutional as worded, the Court shall first attempt to construe or interpret such unconstitutional provision, so as to enable the same to be constitutional as so narrowed or construed. If the Court cannot so limit or construe such work or provision narrowly so as to render the same constitutional, it shall strike or modify only to minimum number of words, phrases, clauses, sentences or paragraphas as will be absolutely necessary to render the remainder constitutional. In so case shall a subordinate clause or phrase or word render its attached major section or provision unconstitutional, but instead shall be severed therefrom entirely, unless such severance renders the remainder wholly meaningless or unconstitutional. SECTION 13.

The Ordinance shall become effective immediately, and shall apply to existing establishments which are presently engaged in the type of activity herein declared to be illegal and a public
