

barrier is there or not. I don't think most businesses were for it," said McCoog.

McCoog said his business was growing at a rate of 70% last year and this year is only growing at a 30% rate. He thinks there is a definite correlation with the construction work which has made it more difficult to get into his business. He said that people often complain about having a hard time getting into his store, and that the drivers will be intimidated by the barriers maning the possibility of accidents more lik 'y to occur.

Siani leaners is going up for sale, and he main reason is the effect that the two year construction job has had on business. Owner Tom Daniels says his business has dropped 50% since the construction started, and he says he is tired of arguing with PennDOT about the restricted access to his business caused by barricades and a limited driveway width.

"What I lose here, I can't make up elsewhere," said Daniels.

"A few more days and I would have been on the road waiting for a cheese hand-out," said the man.

While many businesses will still have to face the problem of concrete barriers and road barricades limiting access to their business, drivers should find relief soon. According to
