

## **Deer Meadow zoning** passes court challenge

In a decision handed down in Luzerne County Court last week by Judge Patrick J. Toole, Jr., the appeal of rezoning land for the Deer Meadow development filed by the Dallas Borough Preservation Association was dismissed.

The judge dismissed the appeal because he believed the borough council followed its zoning ordinance which required public notification of zoning changes.

Under conservation zoning, lots must be a minimum of two acres. Residential lots may be as small as 7,000 square feet, or about 1/6 acre.






