## Entries sought for Rosetti Memorial Art Contest

All area students in grades 7-12 are invited to enter the 9th Annual Suzanne Maria Rossetti Memorial Juried Art Contest. The contest is sponsored by Joe and Sue Hand of Dallas in memory of the daughter of Peter and Louise Rossetti of Saugus, MA. The contest is open to any junior high or senior high school student residing in Dallas, Lehman, Tunkhannock, and Northwest school districts (or who studies art with any private instructor in those districts).

Entries must be delivered to Sue Hand's Imagery, 35 Main Street, Dallas between February 10 and 24. They will be judged separately on each grade level in a variety of categories including pencil, pastel, watercolor, acrylic, oil, ink, scratchboard, mixed media, fibers, photography, prints and miniature drawings and paintings. Photographs must be at least 8"x10". No

entry may exceed 3 feet in either direction, frame or mat included. All entries must be mounted, or matted, or framed (exception: works on canvas board or stretched canvas) and be identified on the back with student name, grade, phone number, and medium. Students may enter five (5) entries. (Five photographs may be entered in addition to the five other entries.)

Ribbons will be awarded in each category on each grade level by a panel of three judges. In addition, many specially sponsored cash awards will be given.

The Winning art work will be displayed at the MacDonald Art Gallery, Regina Hall, College Misericordia, Dallas, PA March 11 through April 1, 1990.

## Girl Scouts honored with certificate of achievement

Penn's Woods Girl Scout Council which serves the Back Mountain, is growing. The national headquarters of Girl Scouts of the U.S.A. has recognized the council with a Certificate of Achievement for their increase in membership of 3.4% to 6813 girls in the council area. All those girls are organized into 465 troops with 3188 adult volunteers working with them. These are the future leaders of our communities, learning how to do it.

The national Girl Scout theme for the year is "The Girl Scouts - as great as you want to make it." Locally the theme has been seen on billboards and in public service announcements on television, and heard on the radio. Council has used the theme throughout the fall, reminding girls that they have choices in program activities that allow them to grow at their own pace and discover options open to them.

Girl Scouting is open to all girls from five to 17. Adults who subscribe to the Promise and Laws are welcomed in leadership roles.

Girl Scouting is not subsidized by any government funds. It is a non-profit organization that receives support from United Way organizations and is otherwise self-supporting through the product sales including the well-known, ever popular, annual Cookie Sale. This year the Cookie Sale will

take place from January 13 to March 9, 1990. Penn's Woods Council will be selling cookies from Little Brownie Bakers in Louisville, Kentucky. They will have the traditional shortbread "Trefolds", oatmeal peanut butter creme sandwich "Do-Si-Dos", "Thin Mints", as well as peanut butter patties "Tagalongs", honey glazed chocolate chip "Country Hearth" cookies, vanilla and lemon "Cabanana Cremes", and those fabulous caramel, coconut and cocoa "Samoas". All varieties of cookies will sell for \$2.50 per box.

Girl Scouts learn a great deal when they participate in the Cookie Sale. First they learn about handling money and making change. Then they learn to be accurate in taking orders and delivering them to their customers. They learn to accept responsibility, and to meet people and sell a product.

Girl Scout Cookies are a once-a-year treat that everyone enjoys. But this is a treat that can only be purchased from a Girl Scout. It is possible, if no Girl Scout comes to take your order, to order directly from the Council by calling the Council Office at 829-2631. It is also possible to order cookies by the case to donate to a favorite charity or soup kitchen. A call to the Council office, or a note with a check for \$31.00, will assure delivery of the case of cookies to the charity.
