The Lake-Lehman Knight wrestlers continued undefeated going into this week after beating Wyoming Area 31-21 Saturday night and Hanover Area 59-8, Wednesday night.

The Knights win over Wyoming Area leaves only Valley West and Lake-Lehman undefeated although the Knights have a tie on their record as a result of the Meyers match two weeks ago.

In Saturday night's competition, the Knights were behind 19-17 after Warrior Jason Prokopchak decisioned Mike Tereska 9-0, but they refused to give up and came back with two decisions, a pin and a draw to pull in front 31-21 and take the meet.

130-lb. Warrior Mark Granteed took an 11-3 bout from Dave Konopke then 135-lb. Knight Rich Peiffer edged out Sam DeAngelo 6-5 but 140-lb. Warrior Jeff Pascoe defeated Jason Clancy 9-2. 145-lb. Terry Martin took a 7-2

decision from Warrior Andy Vavrek before 152-lb. Prokopchak decisioned Mike Tereska.

160-lb. Mike Guerin defeated

Keith Irace 16-9 and 171-lb. J.P. Goodwin decisioned Warrior Jeff Pepe 9-6. 189-lb. Ray Rosencrans gave the Knights six points by flattening Jim Fitzgerald in 2:59 and Hwt. J.J. Konigus gave the Knights their final two points by wrestling to a 5-5 draw with Warrior Chris Sickle.




