

Pennsylvania State Immunization Services Offered at Various Sites

The Pennsylvania Department of Health in Luzerne County is no longer providing welll-child (baby clinic) and immunization services through the State Health Center. These services are being provided by: Rural Health Corporation Centers in Shickshinny (542-4141), Black Creek (384-3201), Freeland (636-1556), and Valley Pediatrics in Edwardsville (288-1188); Hazleton Pediatric Associates, (455-9581), Bethany Venit, M.D. (455-8557), and Nicholas Martyak, M.D., Hazleton (455-9531).

This program provides preventive health care and required immunizations for children from birth through five years of age who cannot access such services through traditional service system. The physician offices will charge for services, but a sliding fee scale based on family income is available. Families who feel they may qualify for the sliding fee scale should inquire about it at the time an appointment is made. Immunization services for individuals over five years of age are available on a fee-for-service basis.

The Family Practice Residency Program in Kingston (288-7451) only provides immunizations for children ages six and over.
