

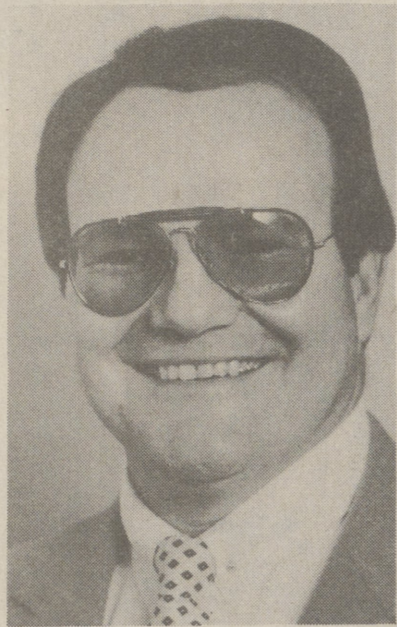

## Three area residents named to Wilkes council

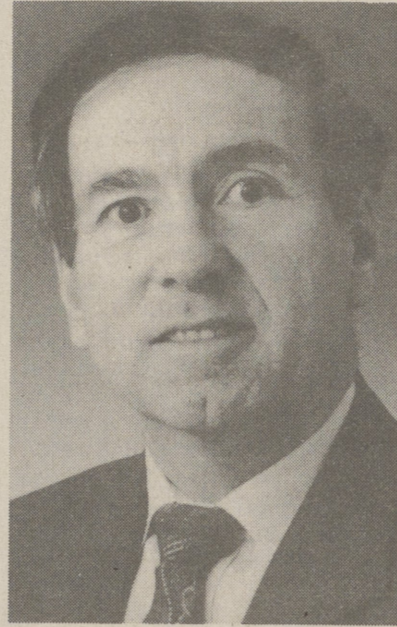

The Council has several purposes including to serve in the exchange of information between the University and the communities represented by Council members; to provide a source of specialized skills and expertise to be used by Wilkes in selected efforts and projects to benefit the University; to provide a forum for discussion of issues and concerns of the University and to recognize alumni and others for outstanding efforts on behalf of Wilkes through election to the Council.

William R. Mainwaring of Shavertown graduated from Wilkes in 1965 with a degree in Accounting and Finance and returned to earn his MBA in 1972. He received the Wilkes University Eugene S. Farley Memorial Alumnus Award in May, 1990. Employed by First Eastern Bank since 1965, Mainwaring has attended the American Bankers Association Lending School at the University of Oklahoma and the Stonier Graduate School of Banking at Rutgers

University.

An active member of the community, Mainwaring currently serves on the Committee for Economic Growth, the Board of Directors of Mercy Hospital, the United Way of Wyoming Valley and as the Vice Chairman and Treasurer of the Board of Mercy Med-Care, Inc. He also serves as Treasurer and Board Member of the Citizen's Voice, Inc. His other affiliations include past Chairman of the Board and Member of the Board of the Greater Wilkes-Barre Chamber of Commerce; Treasurer and Member of the Board of Trustees of the Wilkes-Barre Family YMCA; Penn Mountains Council, Boy Scouts of America Advisory Committee member; Chairman of the Board of Trustees of Wyoming Seminary; and a Member of the Board of Trustees at College Misericordia.

He and his wife Judith are the parents of two children, Jonell and William R., Jr.

Bruce E. Gover earned both his bachelor's and MBA in Finance from Wilkes University. He joined Northeastern Bank in 1977 and was named Vice President and Manager of the Bank's Trust Development Group in 1988.

Gover is a graduate of the National Graduate Trust School at Northwestern University, the Pennsylvania Bankers Association Trust School at Bucknell University and the Manufacturer's Hanover Trust Company's School in New York City.

Gover has served as a part-time faculty member at King's College

and College Misericordia and was a member of the American Bankers Association's Trust Advisory Board in Washington, D.C.

Active in community affairs, Gover is past president of the Wilkes-Barre Rotary Club, his Board affiliations have included the F.M. 84 Lumber Company is the nation's largest privately-held lumber and building supply retailer, with 355 stores nationwide.



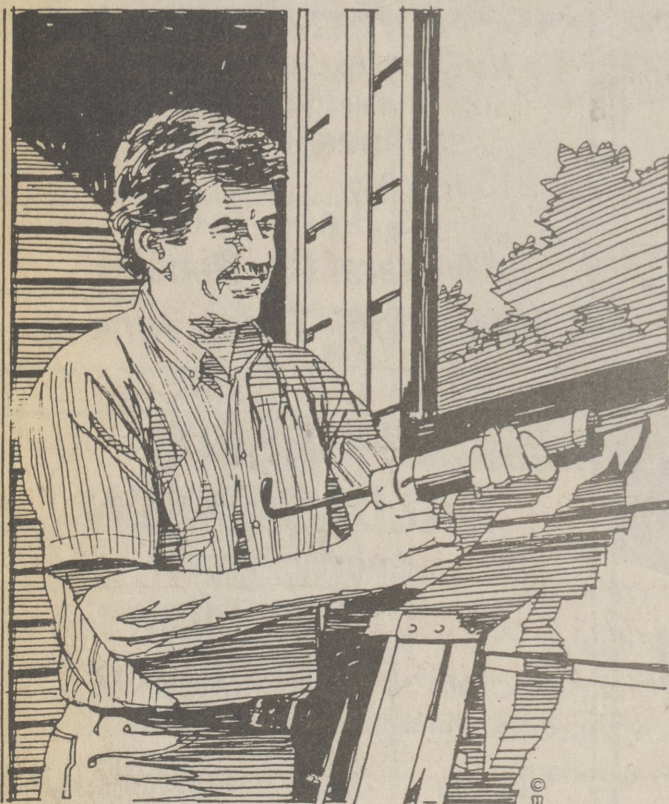
## Shynn named Junior Volunteer of the Month
