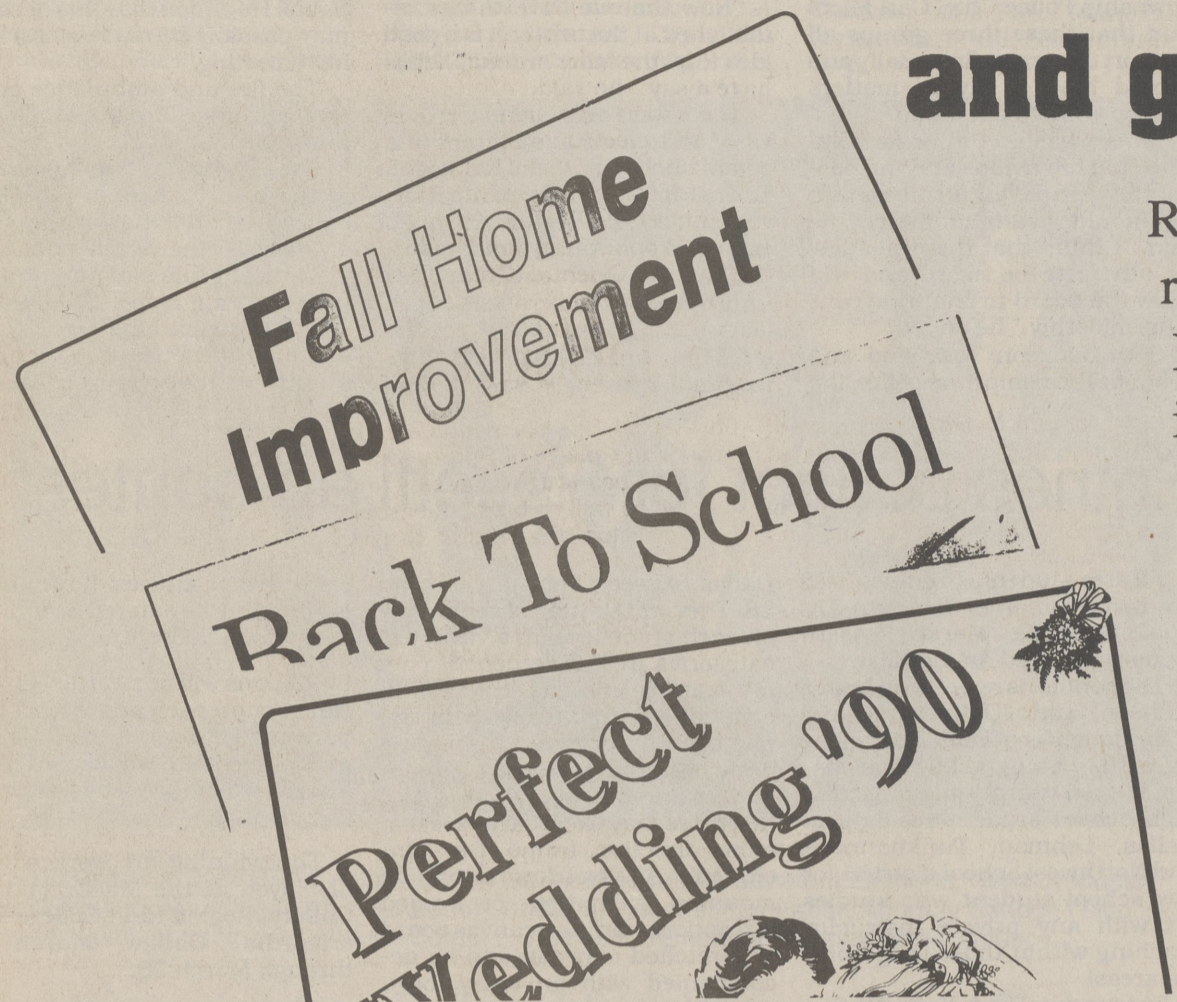

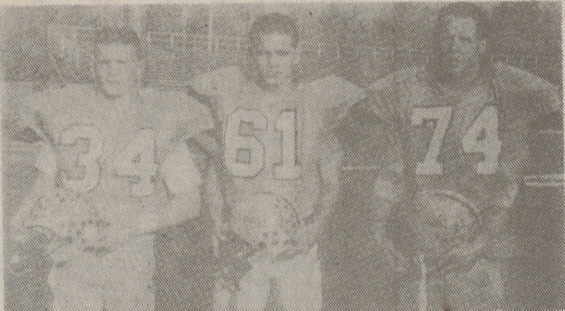

Water company wants \$36,000 reduction in fees

Pennsylvania Gas and Water Company has asked the Jackson Township supervisors to lower building permit fees by about \$36,000 on a reconstruction project at the Crestview Dam.
The request was made at the November 5 meeting of the supervisors when two representatives of PG&W asked that the building permit fee be dropped from four percent to one percent for a project at the dam in Pike's Creek.
PG&W is in the planning stages of a \$21 million dollar water treatment plant at the dam. Company spokesmen, Steven Kauffman told the board that the project is one of three that are required in the Wyoming Valley. PG&W will be

building a treatment plant for water that will serve customers in Plymouth, Nanterke, and at the State Correctional Institute at Dallas.
Jeffrey Sunday, a legal representative for PG&W, then asked the supervisors to consider dropping the township's building permit fee for this specific project.
Sunday gave the board many reasons for the request, noting the size and importance of the project. "We are asking for this project."
