The Permit Area is more specifically located as follows:

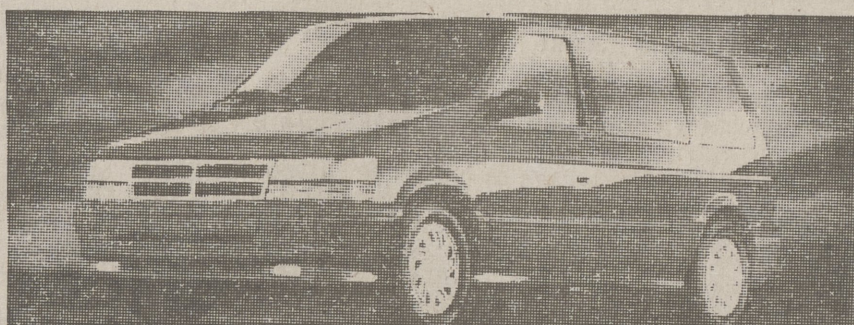

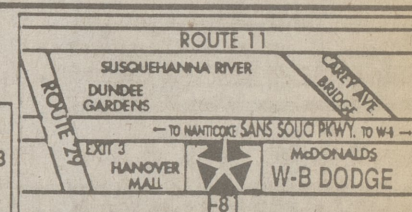
