Machell Ave. beauty shop gets zoners' OK

After considering additional testimony concerning the application of Mrs. Carol Carroll of 368 Machell Ave. for a special exception to the zoning ordinance so that she could open a beauty shop in her basement, the Dallas Borough Zoning Board approved Mrs. Carroll's application.

The zoning board had voted unanimously at its October 24 session to continue the hearing until November 14 so that neighbors Doreen Wills and Elizabeth Lloyd could present additional testimony supporting their objections to the business. Their objections centered on increased traffic on Machell Ave. and possible contamination of nearby residential wells from the Carrolls' septic system. Attorney John Geddes represented the Carrolls at the hearing.

"I have no problem with the beauty shop operating as a business, except where its results will affect my ground well water," Lloyd stated. She presented each zoning board member with an information packet which she said supported

Evidence in the packet included written statements from a geologist, a chemist and a hydrologist, as well as soil survey maps of Luzerne County and a sketch depicting the degree of slope between the two residences which Lloyd had prepared herself.

Dr. Brian F. Orem, a registered

inspector, stated in writing that he sits diagonally across the street would need more information on and uphill from his home. He also the geology of the area and other factors before a proper evaluation could be made of whether or not the Carroll's septic system might need modification.

Lloyd also said that she wanted the Carrolls to prepare an environmental impact study before applying for permission to open the beauty shop. She stated that she knew that such a study would cost the Carrolls \$60 per hour to hire a professional to do this and the study could take between two weeks and two months to complete.

Tim Carroll submitted a sketch of the approximately eight acres which he owns, noting the location of the driveway, parking area, septic system, drain field and proximity to the Lloyd residence, which

stated that his wife's business would occupy less than 20% of his home's total area (600 square feet.) When questioned by a reporter, Carol Carroll stated that she plans to operate her beauty shop part time, approximately part of two to three days a week for the present.

The zoning board stipulated in its approval that Mrs. Carroll's beauty shop take up no more than 20% of her home's total square footage. Anees Barakat abstained from voting on the question, while zoning chairman William Taborand secretary Joseph Dwinchick voted in favor of it. The zoning board informed Mr. and Mrs. Lloyd and Ms. Wills that they have 30 days to appeal the decision if they wish to.


