Graham had also complained that Commonwealth had lengthened a drainage ditch to drain water from the wetland through a culvert into a ponding area across Route 309 behind the company's

According to Irwin Garskof, a biologist for the Baltimore District of the Army Corps of Engineers, the drainage ditch has existed since at least 1979. "We have infra-red aerial photographs which clearly show the ditch extending from the back of the wetland to the culvert underneath the highway. Garskof's office uses infra-red photographs because they are more accurate. Water and plant growth reflect light differently, making it easier to spot the water, he explained.
