## Judge denies Spock's motion to dismiss charges

Spock is accused of accepting a television set as a bribe in exchange for dropping a DUI charge in December 1991. The Lakeview Terrace resident has been suspended without pay since his arrest in June.

Cronin said that although the case has been sent on to trial, to her knowledge, the case will probably not be heard until next year.
