Joy was recently notified that she is among the top ten percent of all high school homecoming queens in Pennsylvania to be selected to compete for the Pennsylvania title March 27-28 at the Hershey Convention Center.

The Pennsylvania queen will represent the state at the national finals in July at the Disneyland Hotel in Anaheim, California.

Being selected as the 1992 Lake-Lehman homecoming queen was easy, compared to what Joy will face during the selection process, where contestants will be judged on poise and maturity during an evening gown show and an hour-long interview.

"I'm very excited, and very nervous, especially about the

interview," she said. "That's what I'm preparing hardest for right now.

"I appreciate the generosity of everyone who took the time to sponsor me," Joy said.

After graduation in June, Joy plans to either attend beauty school or study early childhood development or special education at college. She has many varied interests: bowling, dancing, family and the outdoors.
