The Pennsylvania queen will represent the state at the national finals in July at the Disneyland Hotel in Anaheim, California.

Being selected as the 1992 Lake-Lehman homecoming queen was easy, compared to what Joy will face during the selection process, where contestants will be judged on poise and maturity during an evening gown show and an hour-long interview.

"I'm very excited, and very nervous, especially about the

interview," she said. "That's what I'm preparing hardest for right now."

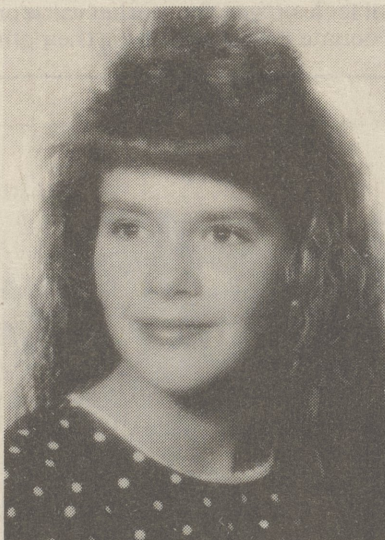
Joy said that she was very surprised when she first received an application form from America's Homecoming Queen, Inc.
