Luzerne County Extension offers adult weight program

Penn State Cooperative Extension of Luzerne County is offering an adult Weight Management Program, "My New Weigh of Life". It is a 10 week program. Participants can register for a Tuesday morning or a Tuesday evening class beginning April 20 and continuing through June 22, 1993. The "My New Weigh of Life"

morning sessions will be held from 9:30 to 11:30 a.m. The Tuesday evening sessions will be held from 7-9 p.m. Both the morning and evening classes will be held at the Luzerne County Extension Office, 5 Water Street, Courthouse Annex, Wilkes-Barre.

"The New Weigh of Life" program is a first step toward permanent weight loss.

The program is research-based and was developed by Dr. Madeleine Sigman, Penn State Extension Nutrition Specialist. Participants will learn to make food choices they can live with for a lifetime. There are no forbidden foods, no endless dieting, and no intense exercise programs.

"My New Weigh of Life" focuses on life changes, on lifelong choices and on lifetime commitment. Participants set reasonable goals and will learn how to make weight loss a permanent change.

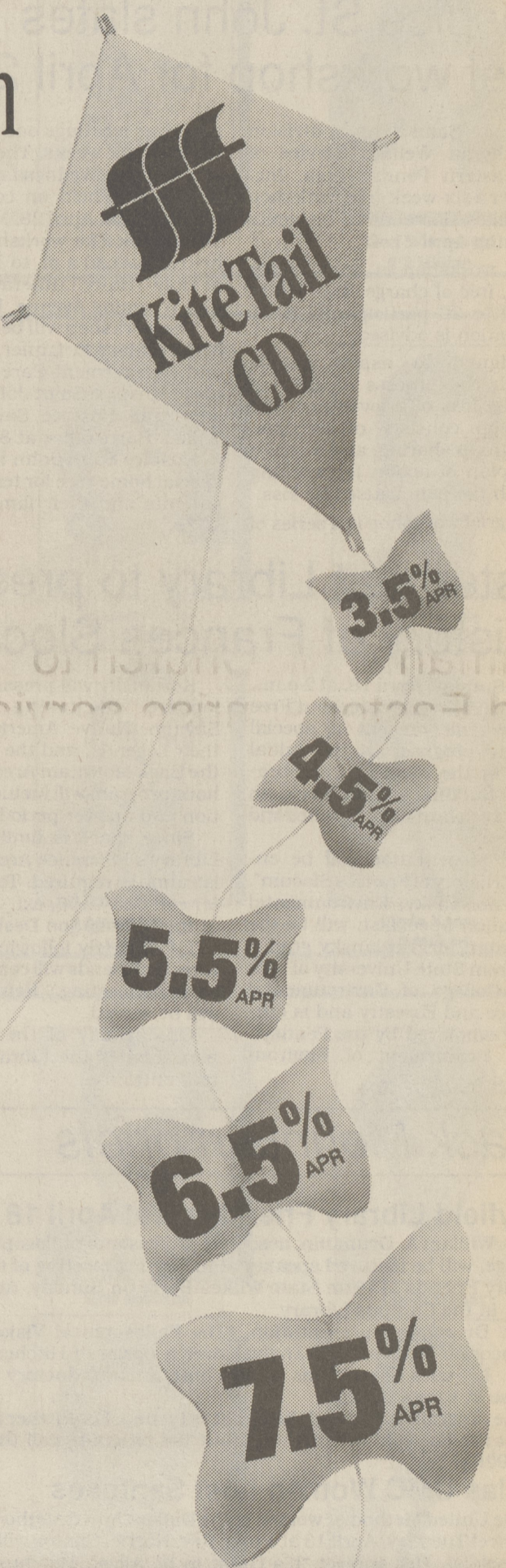
