

## Three still hospitalized after two weekend accidents

Kingston Township police are investigating two weekend accidents which occurred within 24 hours of each other, leaving three people seriously injured.

Police said that Janice Feight, 34, of Walnut Street, Luzerne, was admitted to the Wilkes-Barre General Hospital after an accident Saturday, June 12, shortly after 11 p.m., in which her 1981 Toyota Celica, traveling south on Route 309, for an unknown reason swerved into the passing lane, where its tires hit a slightly raised median strip.

Ms. Feight's car then swerved back across the highway, traveling through a guard rail and coming to rest beneath a traffic sign 132 feet south of Hillside Road, according to the report.

Ms. Feight was transported by the Dallas Ambulance and Medic-II to Wilkes-Barre General Hospital, where she is listed in serious condition in the surgical inten-

sive care unit, according to a hospital spokesperson.

Sunday, June 13, Roger J. Kapinsky, 33, of Forty Fort, and a passenger, David Schmidt, 33, of Swoyersville, were injured in a motorcycle accident shortly before 11 p.m. on Dug Road near Atherholt Drive, when Kapinsky's 1982 Harley-Davidson motorcycle crossed the roadway and became airborne, striking and shearing off a pine tree six inches in diameter, which then fell on the motorcycle and both men, according to the report.

Kapinsky is listed in serious condition in the critical care unit of Nesbitt Hospital, while Schmidt is listed in serious condition at the Wilkes-Barre General Hospital, according to hospital spokespersons.

Medic-I and ambulances from Jackson Township and Dallas assisted police at the scene.

Patrolmen Frank Ziegler and Robert Parrish are investigating both accidents.

trained to rescue people - and sometimes stray kittens - from trees, so we simply applied our rescue knowledge to the bear."

"I've helped people before, but this was my first bear rescue," said Asplundh worker John Killian, who operated the bucket and tied the lines around the sleepy bruin.

As the bear was carefully lowered to the ground, onlookers cheered and applauded, crowding forward for a closer look and a photo, despite repeated warnings from police to keep their distance.

"If that bear wakes up, you're going to have problems," Miers warned the crowd.

Game Commission officials said that the bear, secured to a litter-type device on the back of their truck, would be taken "to the mountains" and released.

An opportunistic feeder, the bear was probably in the area looking for food in residents' garbage cans, since the grubs and berries which it normally feeds on aren't ripe yet, Miers said.

Although bears are normally shy, they can become aggressive if they believe that they are cornered, he added.

"Our main concern was protecting both the people and the bear so that no one got hurt," Miers said. "One of our biggest problems is that people want to get a closer look and end up chasing the bear, which then retreats, climbs a tree or becomes aggressive."

If area residents see a bear in their yard, Miers recommends that they call the Game Commission at 675-1143 and leave the bear alone.
