Floyd G. Miller, of Alderson, Harveys Lake, died Feb. 24, 1994, in Meadows Nursing Center, Dallas.


Born in Duryea, he was the son of the late John P. and Rosemary Renfer Miller. He was a graduate of Duryea High School and attended Penn State University.

He resided in Hawthorne, NJ for more than 50 years, prior to moving to Harveys Lake, two years ago.




