· A new 13-week course entitled Microcomputer Applications in Business which can be taken for three credits or as a non-credit workshop, which provides an introduction to the current and most frequently used software applications in business - Windows, Word, Excel, Powerpoint and Access.

• Demonstration courses on the Internet, the information superhighway, which will include the history, user tools, and implications for the future of communications, will be offered in June.

The workshops and courses are taught by Penn State faculty. Fees and times for the day and evening workshops vary.


