Baker to head Governor's Northeast Regional Office

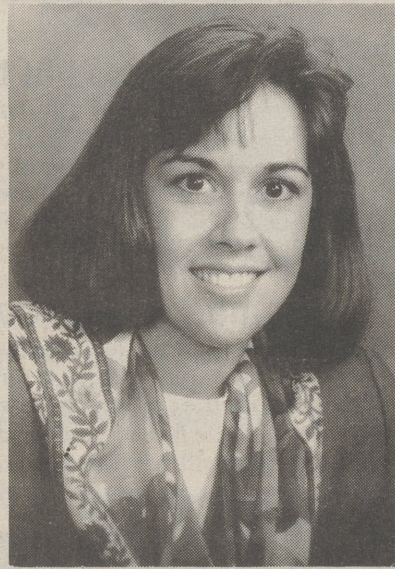

KT lists campaign sign rules

All political candidates who plan to post signs in Kingston Township are reminded that signs can be posted no earlier than thirty days prior to any election and must be removed no later than thirty days after the election.

Campaign signs may not exceed four square feet in size and signs cannot be attached to fences, trees, or utility poles.

A \$100 bond must be deposited with Kingston Township prior to issuance of a sign permit and the posting of any sign. The bond will be returned if all signs are removed within thirty days after the election.

A permit to post political signs can be obtained from the Township Zoning Office, 11 Carverton Road, Trucksville. Questions may be directed to the zoning officer at 696-3809.
