## Region 1: 2 incumbents, 1 challenger

In Region I, Kern, incumbent Elizabeth Sichler and Kopcha are contending for two seats.

Seeking his second term, Kern says it will be his last.

"Two terms are enough," he said. "You tend to get a bit stale if you stay in any longer than that. I favor some type of term limit to allow other people with good ideas to have a chance at it.'

A Lake-Lehman graduate and medical salesperson, Kern has served on the transportation and buildings and grounds committees, and has represented the district on the board of the West Side Area Vocational-Technical School.

"If the Taxpayers' Association candidates all are elected, you'll see real fiscal responsibility which will not harm educational programs," he said. "I want to keep our educational programs and not hurt the students, but I also want a zero millage increase."

Lois Kopcha has become so committed to making education everyone's business that she quit her job as a licensed practical nurse to have more time to work with taxpayers' groups.

Formerly vice-president and presently secretary of the Lake-Lehman Taxpayers Association, she is also on the board of the Wilkes-Barre Area Taxpayers' Association and a member of the Luzerne County Public Forum and the Northeast Taxpayers' Alliance.

"I believe in it," she said simply. In addition to attending all Lake-Lehman school board meetings, Kopcha goes to different area school board meetings, especially at budget time, to see how other districts do business.

"I want to make our board taxpayer-friendly," she said. "The only way to change things is to get

Her primary goal, if elected, is to make the board accountable to its constituents.

questions, not to transact business," she said. "The people must understand where the district is going."

Since the taxpayers' group became active, Kopcha said she has seen smaller millage in-

"For a while it went up steadily," she said. "Our group has been trying to keep the millage increases down.'

She said her organization could have saved the district \$150,000 - if the school board would have

listened to them.

"Our athletic director and driver training instructors each cost the district \$75,000 in full-time teachers' wages and benefits," she said. "The athletic director doesn't teach any classes - he does paperwork and pushes equipment around on carts during the first three periods of the day for audio-visual duty, then does the athletic director's work for the last four periods of the day, for which he gets an additional \$5,000. He gets another \$5,000 for coaching basket-


