Dog officers to check for pets' license, rabies tags

vassed for unlicensed dogs during May and June according to Eugene Dziak, Regional Dog Law Supervisor for the Pennsylvania Department of Agriculture.

Dog wardens from the department's regional office in Tunkhannock will form teams to call on owners of unlicensed dogs.

Owners who failed to obain 1995 licenses for their dogs should do so immediately, since violators can be cited to appear in court and fined up to \$300.

Licenses are required for all dogs six months of age and older. The license can be obtained from the Treasurer's Office in Luzerne County Courthouse.

At this time of year, dogs often form packs that attack livestock and other domestic animals. If the dog owners are identified, they can be required to pay for the resulting damage in addition to the fine. Dziak said.
