Orders can be given to any member or call the hall at 675-1565.

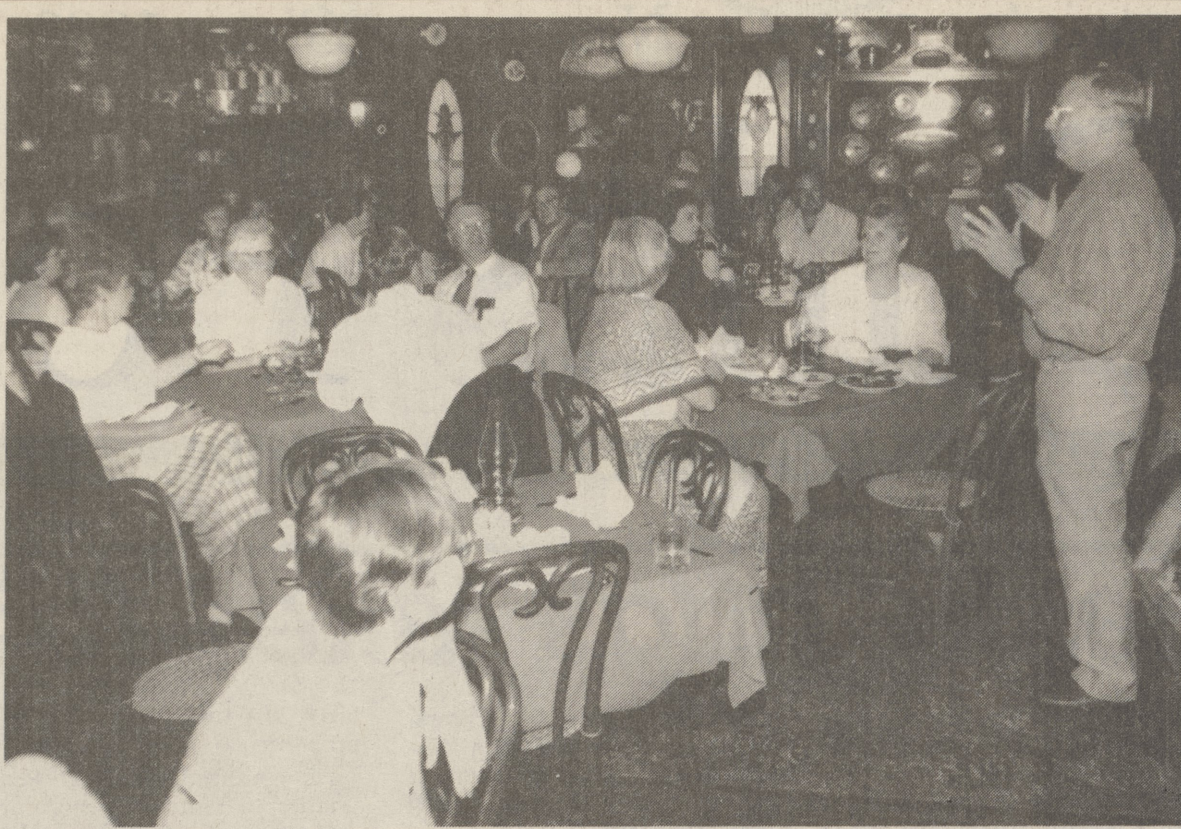
Cookies are \$2 a dozen and can be picked up the day of the sale between 11 a.m. and 3 p.m.

The 18 board members are selected from among 250,000 travel agents representing 32,000 full-service travel agencies nationwide.

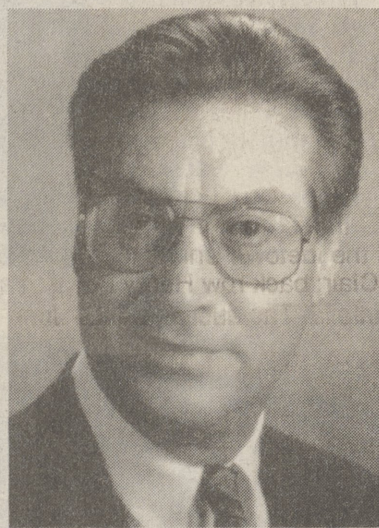
