DUI case dropped because suspended cop can't testify

DALLAS TOWNSHIP - A DUI charge and two traffic citations against Pittston resident Paul W. Vincent were dismissed because the arresting officer, himself facing a theft charge, didn't come to the preliminary hearing August 25 before District Magistrate James Tupper.

Vincent, represented by public defender Joseph Sklarosky, had been arrested by Kingston Township patrolman Robert Weiss May 21, 1994, for driving while under the influence. Weiss also cited him for driving 62 mph in an area posted at 35 mph and driving with a suspended operator's license. The traffic citations were also dismissed, according to court records.

Weiss was suspended with pay from his job as a Kingston Township patrolman after he admitted taking \$106.90 from a sealed envelope in a locked evidence room in late March.

He waived his right to a preliminary hearing before District Magistrate Fred Pierantoni August 23. No trial date has been set

Weiss was suspended without pay and benefits September 1, according to township manager Jeff Box, who met with police chief James Balavage and solicitor Benjamin Jones.

"We felt it was the appropriate thing to do at this time," Box said. Balavage said most of Weiss's pending cases were assigned to other officers wherever possible, but he couldn't reassign the DUI case.

"If Weiss had testified, his credibility would have been questioned," Balavage said. "No other officers had been present during the arrest, who could testify in his place, so we couldn't reassign the case. It was a no-win situation for the department."

18 year old faces DUI, other charges

Clark Cavanaugh, 18, of Upper Swamp Road, Hunlock Creek, waived his right to a preliminary hearing on charges of driving while under the influence, reckless endangerment and fleeing police August 31 before District Magistrate James Tupper.

DUI charge in car/truck

DALLAS TOWNSHIP - The driver of a car involved in an accident with a tractor-trailer on Route 309 in Kunkle has been arrested for driving while under the influence (D.U.I.)

According to court records, D. A. Moyer, 21, of Tunkhannock waived his right to a preliminary hearing on the D.U.I. charge August 25 before District Magistrate James Tupper. The charges will be sent to Luzerne county court.

He was also cited for driving on the wrong side of the roadway, according to court records.

The accident occurred around 3 a.m. June 23, when Moyer's car, which had been traveling north on Route 309 in Kunkle, moved into the southbound passing lane of the highway and collided with a tractor-trailer, which had been traveling south. His car split into three pieces, with its rear end in the southbound lane, the front end approximately 25 feet away in the northbound lane and the dash and motor, which had caught fire, in the woods 45 to 50 feet from the point of impact.

The tractor-trailer, an older model Freightliner owned by National Freight of Vineland, NJ, flipped on its side after the impact and skidded 300 feet uphill. The driver, Randy Korb, was treated at Geisinger Wyoming Valley and released.

According to the police report, Moyer became combative with them, tried to set himself on fire and tried to grab patrolman Wayman Miers's gun belt.

A passenger in Moyer's car, Brad Casey, was taken by helicopter to Community Medical Center in Scranton, where he was treated in the trauma unit.
