2 charged with using forged plates

Edwardsville resident Aleksey Bash, 21, and Kingston resident Michael Dombek, 25, waived their rights to preliminary hearings on charges of using altered vehicle documents before District Justice James Tupper.

Bash was arrested April 4 by Dallas Borough patrolman James Drury after a routine records check showed his license plate to be two months out of date, while the inspection sticker was good until September. Police found the inspection sticker had been removed from another vehicle.

Bash was represented by public defender Jonathan Blum and is free on \$300 bail.

CHARGES DISMISSED

Charges of D.U.I. against Noxen resident Joseph Luketic, 40, were dismissed at a preliminary hearing June 5.

He was arrested Jan. 18 by Lake Twp. patrolman John Young at the scene of a two-vehicle accident, but the charge was dismissed because police couldn't prove he was actually driving one of the cars involved, according to District Magistrate James Tupper.

Luketic had refused to take a blood alcohol test, which results in the automatic loss of one's driver's license for a year under state law. He may appeal the suspension, Tupper said.

Luketic paid a total of \$325 in fines and \$77.50 in costs for related charges of public drunkenness and disorderly conduct for using obscene language to police. He was represented by attorney Mark Mack.

TO FACE TRIAL FOR **POSSESSING MARIJUANA**

Kingston resident John Ciocca waived his right to a preliminary hearing on charges of possession and selling of drugs June 5.

He was arrested Nov. 29 by Pennsylvania State Police trooper Richard Geffken after selling Geffken .25 ounces of marijuana for \$60 in the parking lot of the Burger King in Shavertown.

Ciocca was represented by attorney Joseph Yeager and is free on \$10,000 bail.

Mazula's license suspended, Watkins' hearing June 14

DALLAS - The state has suspended the licenses for another six months of an area dentist who gave anesthetic to a Sweet Valley

Dr. Joseph Mazula, an oral surgeon who gave an inhaled anesthetic to Jonathan Walski at the office of Dr. William Watkins. is licensed to practice dentistry and give all types of anesthetic through the Board of Dentistry. an arm of the Department of State's 27-board occupational licensing division.

The board suspended Mazula's licenses for 30 days May 14 and Watkins's licenses to practice dentistry and administer nitrous oxide May 17.

After a hearing last week, it voted to continue Mazlua's suspension for another six months. pending the outcome of further investigation. Watkins's hearing before the board is scheduled for

"It's not a routine thing - in the past four years we have issued only two such suspensions," said Board of Dentistry press secretary David Hixson. "We suspend licenses in only the most extreme cases, although varying degrees of charges are often filed with us."

Mazula has the right to apply for a dentist's license in another state, but the discipline would be permanently noted in Pennsylvania and picked up by another state during a routine background check, Hixson said.

Jonathan, 3, died May 1 at Watkins's office from a reaction to the anesthetic, according to the results of an autopsy performed the same day by Luzerne County coroner Dr. George Hudock. According to the investigation, neither dentist had the monitoring and emergency resuscitation equipment required by the state.

A criminal investigation by Dallas Borough police chief Jack Fowler and Luzerne County detective Richard Capitano is continuing, according to district attorney Peter Paul Olszewski. No criminal charges have been filed.


