Watkins could treat several cavities in his mouth.

"Within the near future the prosecution will review the facts and determine whether or not to file additional charges," said Department of State press secretary David Hixson. "The investigation is still continuing."

Depending on the findings, the case could also go the other way, with no other charges filed against Watkins, he added.

"We all felt very bad about it - it is a real tragedy and we're very upset," Watkins said. "I feel justice was served, but it's still a very unfortunate incident."

Mazula's licenses to practice dentistry and administer any type of anesthetic were suspended for another six months after a preliminary hearing June 10. Depending on the outcome of the board's investigation, there is "a strong possibility" that additional charges will be filed against him, Hixson said.

Charges filed through the Board of Dentistry are called administrative charges, which carry penalties ranging from temporary suspension of professional licenses or fines to permanent suspension, Hixson noted. Penalties are permanently noted on the professional's record.

The Luzerne County district attorney's office, assisted by the Dallas Borough police, is still investigating the possibility of filing criminal charges against the two dentists.




