Family evicted from Harveys Lake home

HARVEYS LAKE - A woman. her two sons and their dogs have been forced to find a new home after the house they were renting was condemned.

Health inspector John Roper, fire chief Frank Lutinsky, SPCA humane police officers Robert Arnold and Edward Dubil and codes enforcement officer Paul Grimes inspected the home along Route 415 Friday afternoon and ordered Ann Miller and her sons to leave after they found rooms stuffed with trash and electrical wires hanging from the ceiling. The 'names of her sons weren't available.

"You can't even walk in there," said V.I.S.I.O.N. director Vince Kabacynski after inspecting the house with borough officials. "Our main concern was that they couldn't even get into some of the rooms because they were so packed with trash. There was an enormous amount of newspapers, magazines, shopping bags and other items piled from floor to ceiling.

The Millers are staying with a family friend until they can find another home, he added. V.I.S.I.O.N. is providing them transportation to and from the condemned house to remove their personal belongings and clean out

"The smell inside and outside was unbelievable," Grimes said. "It's a fire hazard," Lutinsky said, shaking his head.

The impact analysis requirement was added after homeowners, members of the Lake Louise Association, wrote to the supervisors expressing their concerns on the development's possible effect on the lake's watershed, land, lake water, aquatic life and wildlife.



High-speed motorcycle chase results in charge, citations

Pittston resident David Carl Rhodes, Jr., 19, waived his right to a preliminary hearing on a misdemeanor charge of fleeing police pursuit July 24 before District Justice James Tupper.

He was also cited for driving through a stop sign, exceeding the posted speed limit, reckless driving, removal or fraudulent use of a registration and driving without an insurance card.

Related citations for driving on the wrong side of the road, driving an unregistered vehicle, driving through two more stop signs, driving with the wrong class of driver's license and improper display of a license plate, and a related misdemeanor charge of reckless endangerment were dismissed, according to court records.
