# Student faces possible expulsion for bringing knife to school

**DALLAS TOWNSHIP** - A 17-year-old Dallas High School student faces possible expulsion because he brought a small knife to school Aug. 30.

"It was a small knife on a key chain," said police officer Jeff Dennis, who investigated the incident. "He pulled it from his pocket and pointed it at another student, supposedly in fun. The boy said he didn't think it was a weapon."

Police will file a misdemeanor charge of possession of a weapon on school property with the Luzerne County Juvenile Court, Dennis added. He didn't identify the student, who lives in Dallas Borough, because he is under

18 years old.

"Bringing the knife to school was a mistake of judgement on the part of the student," said high school principal Frank Galicki. "In our investigation we found no evidence at all that he intended to use it to harm any other students. It was a very small knife, the type used to cut baling twine, but we have a zero tolerance policy for weapons in school."

The boy has been suspended for 10 days, until the school board and the solicitor decide upon further action, according to superintendent Gerald Wycallis. In many cases, state law requires automatic expulsion of students caught carrying weapons in school, he added.

## DISTRICT COURT BRIEFS

### 4 charged with weapon possession

Nanticoke resident Jason Wylie, 19, Wilkes-Barre residents Jeffrey D. Condiff, 28, and Shawn M. Ruminski, 19, and Glen Lyon resident Gregory M. Vidumsky, 19, waived their rights to preliminary hearings on misdemeanor charges of possession of a firearm with intent to commit a crime.

Related felony charges of carrying a firearm without a permit against the four were dropped, according to court records.

They were arrested July 24 by Dallas Twp. officer Wayman Miers after police saw their car leaving the Dough Company restaurant on Rte. 309 while it wasn't open for business.

When Miers pulled over the car, which Wylie was driving, at New Goss Manor, he saw a passenger later identified as Vidumsky stuff something into his left side and saw an empty

pistol holster on the floor of the back seat on the passenger's side.

Police found a Smith & Wesson .357 pistol containing four rounds of live ammunition under the front seat, an empty case of .357 ammunition, an empty cylinder, a BB pellet gun, a crowbar, a nail puller and a jack handle.

According to a records check, the pistol is registered to Jeffrey Jay Smith of Wilkes-Barre, who told police he had loaned it to his brother, Justin Smith, who was not in the car. All four men told police they didn't know the gun was in the car.

Assisting in the arrest were Dallas Borough patrolman James Drury, Dallas Twp. officer Fred Rosencrans and Kingston Twp. officer Robert Parrish.

They were represented by public defender Jonathan Blum and imprisoned in default of bail.

### DENTIST WAIVES RIGHT TO PRELIMINARY HEARING

Dr. Joseph Mazula, the anesthesiologist charged with involuntary manslaughter in connection with the May 1 death of Jonathan Walski, 3, of Sweet Valley, waived his right to a preliminary hearing Sept. 6.

The child died after receiving anesthetic from Mazula and suffering an adverse reaction to the medication while undergoing a routine procedure in the office of Dr. William Watkins in Dallas.

The state board of dentistry suspended his licenses to practice dentistry and administer anesthesia for six months June 4.

Mazula is free on \$25,000 bail. He was represented by attorney Harold Kane.

### D.U.I. CASE SENT TO LUZERNE COUNTY COURT

James A. Sickler, 44, who told police he lives on the streets, waived his right to a preliminary hearing Sept. 4 on a charge of D.U.I. He was also cited for following another vehicle too closely, careless driving and driving with a suspended license, according to court records.

He was arrested Sept. 3 by Dallas Twp. officer Brian Feeney after being involved in a one-vehicle accident on Rte. 415 near Center Hill Road. After failing field sobriety tests, he refused a blood alcohol test, which results in automatic suspension of his driver's license for one year under state law.

### Kingston Twp. issues zoning permits

Kingston Township zoning officer Ben Gorey issued 47 permits and collected \$3,121 in fees in August.
