# **Kingston man to stand trial for** carrying weapon, altering plates

When first asked for his driver's license, Swan first produced a different ID card instead. After failing field sobriety tests, he took a blood test which showed his blood alcohol level to be .157.

Many local businesses came to show support, while veteran auctioneer Bob Earl donated his services.


