sors offered to temporarily barricade a culvert that drains on the Clarks' property so the water can be diverted further down the road.

Ide explained, "It's going to be a temporary barricade that we can easily remove with a backhoe." The culvert will be barricaded in the spring if the Clarks agree to sign a release that would not allow them to hold the township liable for any damage the blocked culvert would cause.

The board also addressed accusations of township "negligence" from dissatisfied residents. In a letter to the township supervisors, Elizabeth Fulton expressed disgust with the township's response to zoning violations by Danny Major. Major repairs small engines in a shop on Jackson Road which is 100 feet outside the township's agricultural zone.

Although in violation, Major has appealed and is awaiting a hearing. Until then, board members have taken "a wait and see attitude," explained Ide. In response to the complaints, Sutton said, "We've done everything we're supposed to do.'

Also during the meeting, the board voted to accept an application for rezoning from Kenneth


