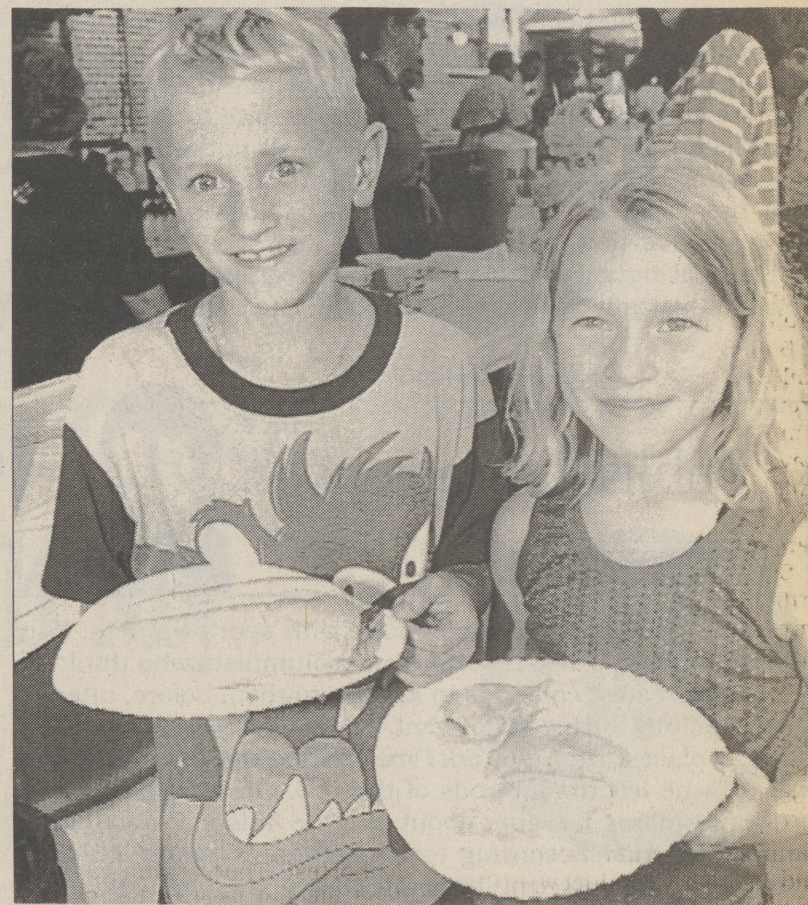
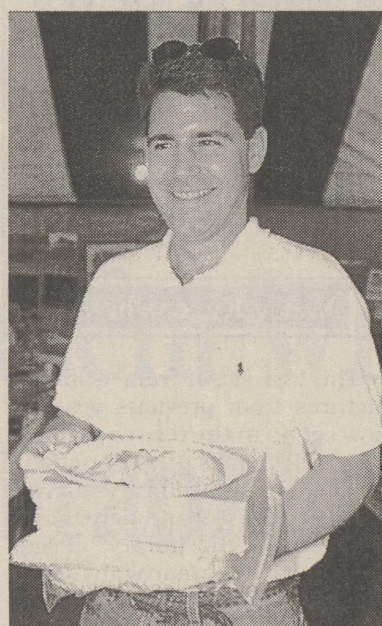
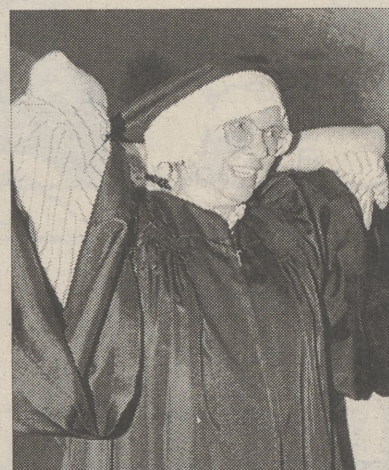




## FUN AND GAMES
